- 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to be reimbursed for a personally procured move (PPM).
- 2. The Board, consisting of particles allegations of error and injustice on 8 December 2021 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
- a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
 - b. On 5 December 2016, Petitioner was issued NAVPERSCOM Recall Order
 - c. On 14 December 2016, Petitioner was issued a Modification to Recall Order
 - d. On 9 January 2017, Petitioner reported to
 - e. On 19 December 2019, Petitioner was issued a Modification to Recall Order
 - f. On 7 January 2021, Petitioner signed an agreement to remain on active duty.
 - g. On 3 July 2021, Petitioner initiated a PPM.
 - h. On 29 October 2021, Petitioner was issued BUPERS Separation Order

- i. On 15 November 2021, Petitioner was notified by the household goods audit team (HHG-AT) that his claim for reimbursement request was denied.
- j. On 8 January 2022, Petitioner was released from active duty and transferred to the Navy Reserve.

CONCLUSION

Upon review and consideration of all the evidence of record, the Board agreed that Petitioner did conduct a PPM before issuance of orders in accordance with reference (b), paragraph 051302. However, the Board agreed that Petitioner's BUPERS Separation Order were not issued in a timely manner to afford Petitioner to conduct his HHG move which he is entitled. The Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's BUPERS Separation Order were issued on "2 July 2021" vice "29 October 2021."

Petitioner is advised to resubmit his personally procured move (PPM) claim, orders, receipts, and a copy of this Board of Correction of Naval Records (BCNR) decision letter to the Household Good Audit Team (HHG-AT) for re-adjudication.

Settlement of claim is chargeable to the line of accounting on the Petitioner's BUPERS Separation Order.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

- 4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.
- 5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
