Dear █,

This is in reference to your application for correction of your naval record pursuant to Section 1552 of Title 10, United States Code. After careful and conscientious consideration of relevant portions of your naval record and your application, the Board for Correction of Naval Records (Board) found the evidence submitted insufficient to establish the existence of probable material error or injustice. Consequently, your application has been denied.

A three-member panel of the Board, sitting in executive session, considered your application on 12 April 2022. The names and votes of the members of the panel will be furnished upon request. Your allegations of error and injustice were reviewed in accordance with administrative regulations and procedures applicable to the proceedings of this Board. Documentary material considered by the Board consisted of your application, together with all material submitted in support thereof, relevant portions of your naval record and applicable statutes, regulations, and policies. In addition, the Board considered the advisory opinion contained in Headquarters Marine Corps memorandum 1070 MPO of 14 February 2022 which was previously provided to you for comment.

The Board determined that your personal appearance, with or without counsel, would not materially add to their understanding of the issues involved. Therefore, the Board determined that a personal appearance was not necessary and considered your case based on the evidence of record.

You requested to establish entitlement to Continuation Pay. The Board, in its review of your entire record and application, carefully weighed all potentially mitigating factors, to include your assertions. The Board concluded that you did not meet the eligibility criteria to receive Continuation Pay in accordance with Marine Corps Bulletin 1800 and Marine Corps Administrative (MARADMIN) message 663/19. Specifically, the policies indicate Continuation Pay must be elected prior to completing 12 years of service as calculated from the pay entry base date (PEBD). Additionally, the policies specify that notification of eligibility would be sent to eligible Marines 180 days and 30 days before reaching 12 years of service. A review of your record indicates your PEBD is 29 March 2008, and you enrolled in the Blended Retirement System on 7 January 2018. Furthermore, Continuation Pay eligibility notifications were sent to

you via leave and earning statements and Marine Online notifications prior to your 12 year anniversary. Moreover, MARADMIN 663/19 authorized the submission of NAVMC 11905 via Electronic Personnel Action Request (EPAR) or by e-mail, if EPAR was unavailable, thereby mitigating the restrictions in place during the Corona Virus (COVID-19) pandemic. In this connection, the Board substantially concurred with the comments contained in the advisory opinion.

You are entitled to have the Board reconsider its decision upon submission of new matters, which will require you to complete and submit a new DD Form 149. New matters are those not previously presented to or considered by the Board. In this regard, it is important to keep in mind that a presumption of regularity attaches to all official records. Consequently, when applying for a correction of an official naval record, the burden is on the applicant to demonstrate the existence of probable material error or injustice.
