- 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to establish Petitioner's correct military service period on Certificate of Release or Discharge from Active Duty (DD Form 214) effective 10 December 2003.
- 2. The Board, consisting of \_\_\_\_\_, and \_\_\_\_ reviewed Petitioner's allegations of error and injustice on 24 February 2022 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, he exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings:
- a. On 17 August 1994 Petitioner enlist for 8 years Delayed Entry Program (DEP) in the Marine Corps Reserve.
- b. On 27 June 1995 Petitioner request discharge from DEP, and enlists and enters active duty in the Regular Component of the Marine Corps for a period of 5 years.
  - c. On 11 November 1999 Petitioner reenlist in the Marine Corps for 4 years.
- d. On 10 December 2003 Petitioner honorably discharged from Marine Corps after completion of required active service. Issued DD Form 214 effective this date. Section 12 (Record of Service) reads as follows: Item 12a (Date Entered AD this Period) 1999 year, 12 month, 11 day; Item 12b (Separation Date this Period) 2003 year, 12 month, 10 day; Item 12c (Net Active Service this Period) 04 years, 00 months, 00 days; Item 12d (Total Prior Active Service) 04 years, 00 months, 00 days;

Item 12e (Total Prior Inactive Service) 00 years, 10 months, 11 days. There are no other DD 214s resident in Petitioner's Official Military Personnel File (OMPF).

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board determined per reference (b), effective 27 June 1989, the issuance of DD Form 214 for reenlistment was prohibited. The Board concluded per reference (c), the Petitioner's DD Form 214 effective 10 December 2003 contained administrative errors, warranting relief.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner be issued Correction to DD Form 214 (DD Form 215) for DD Form 214 effective 10 December 2003 and make appropriate distribution to all required agencies.

Item 12a: "1995 year, 06 month, 27 day" vice "1999 year, 12 month, 11 day"

Item 12c: "08 years, 05 months, 14 days" vice "04 years, 00 months, 00 days"

Item 12d: "00 years, 00 months, 00 days" vice "04 years, 00 months, 00 days"

Item 12e: "00 years, 10 months, 10 days" vice "00 years, 10 months, 11 days"

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
