1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to establish Petitioner's Expiration of Active Service date reflects 5 August 2022 vice 5 August 2023.

2. The Board, consisting of [REDACTED], [REDACTED], and [REDACTED] reviewed Petitioner's allegations of error and injustice on 24 March 2022 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. On 6 June 2018, Petitioner signed a Record of Military Processing – Armed Forces of the U.S. (DD Form 1966) with an obligation of 5 years and enlisted for Marine Corps Security Forces (MCSF) and Marine Corps Security Guard (MSG).

c. On 12 July 2018, Petitioner signed a Statement of Understanding (Annex B) for the MG program (MCSF and MSG) for a 5 year obligation.

d. On 6 June 2018, Petitioner signed an enlistment/reenlistment document Armed Forces of the U.S. (DD Form 4) for 8 years with an End of Obligated Service (EOS) of 5 June 2026. Petitioner entered active duty on 6 August 2018 for 5 years with an End of Current Contract (ECC) of 5 August 2023.

e. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that the Statement of Understanding signed by Petitioner on 12 July 2018 is under the MCSF and MSG program under the 0300 military occupational field option for a 5-year term of enlistment. Petitioner should have been sent to MCSF if there was not an MSG class available; therefore, the Marine Corps failed to honor Petitioner's contract and his term of enlistment should be 4 years vice 5 years.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's enlistment/reenlistment document (DD Form 4) executed on 6 August 2018 is for a term of 4 years vice 5 years. Note: This will establish an ECC of 5 August 2022.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
