1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that her naval record be corrected to show Petitioner reenlisted on 13 November 2020 for a term of 6 years, and was eligible for and received a Selective Reenlistment Bonus (SRB).

2. The Board, consisting of [REDACTED], [REDACTED], and [REDACTED] reviewed Petitioner's allegations of error and injustice on 10 February 2022 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. On 15 November 2010, Petitioner entered active duty.

c. On 5 April 2019, Petitioner reenlisted for 4 years with an End of Active Obligated Service (EAOS) of 4 April 2023.

d. In accordance with reference (b), FY20 SRB award Plan (N13SRB 004/FY20) listed a zone "B" SRB with an award level of 1.0 (\$30,000 award ceiling) for the MA rate.

e. On 26 August 2020, Petitioner was issued official change duty orders (BUPERS order: [REDACTED]) with a required obligated service to January 2026, while stationed in [REDACTED] with an effective date of departure of December 2020. Petitioner's ultimate activity was Newport [REDACTED] for duty with an effective date of arrival of 29 January 2021.

f. In accordance with reference (b), FY21 SRB Award Plan (N13SRB 001/FY21) listed no zone "B" SRB for the MA rate. Decreased award levels were effective after 30 days of this notification.

g. On 13 November 2020, Petitioner reenlisted for 6 years with an EAOS of 12 November 2026.

h. On 7 December 2020, Petitioner was issued official modification to change duty orders (BUPERS order: [REDACTED]) with a required obligated service to January 2026, while stationed in [REDACTED] with an effective date of departure of December 2020. Petitioner's ultimate activity was [REDACTED] for duty with an effective date of arrival of 29 January 2021.

i. On 10 December 2020, Petitioner transferred from [REDACTED].

j. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that Petitioner was in receipt of BUPERS Order [REDACTED], which required obligated service to January 2026. The 6-year term reenlistment contract of 13 November 2020 was not released in Navy Standard Integrated Personnel System (NSIPS), causing her SRB Authorization be rescinded.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner was discharged on 12 November 2020 and reenlisted on 13 November 2020 for a term of 6 years.

Note: This change will entitle the member to a zone "B" SRB with an award level of 1.0 (\$30,000 award ceiling) for the MA rate. Remaining obligated service to 4 April 2023 will be deducted from SRB computation.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.
