1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to show Petitioner was eligible for and received a Selective Reenlistment Bonus (SRB).

2. The Board, consisting of [REDACTED], [REDACTED], and [REDACTED] reviewed Petitioner's allegations of error and injustice on 24 February 2022 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. On 11 October 2017, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 10 October 2021 and Soft End of Active Obligated Service (SEAOS) of 10 October 2022.

c. On 31 March 2020, Petitioner signed an agreement to extend enlistment for 2 months with a SEAOS of 10 December 2022 in order to match EAOS with Projected Rotation Date (PRD) of December 2022.

d. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component (AC) and Full-Time Support (FTS), superseding NAVADMIN 272/19.

Subj: REVIEW OF NAVAL RECORD ICO [REDACTED], USN, XXX-XX-[REDACTED]

Sailors must now reenlist within 365-days of their EAOS (as opposed to 270-days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who can reenlist at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

e. In accordance with reference (c), FY21 SRB Award Plan (N13SRB 005/FY21) listed a zone "A" SRB with an award level of 1.5 (\$30,000 award ceiling) for the EM rate.

f. On 1 September 2021, Deputy Chief of Naval Personnel notified Petitioner that he was authorized immediate in-rate reenlistment in the AC with an end date of December 2022.

g. On 26 October 2021, Petitioner signed a Command Career Request (NPPSC 1160/1) for a 6 year reenlistment effective 24 November 2021, and it was approved by cognizant authority on 4 November 2021.

h. On 24 November 2021, Petitioner reenlisted for 6 years with an EAOS of 23 November 2027.

i. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that a review of the NSIPS reflects there was no SRB precertification submitted. If the Command Career Counselor had submitted the SRB precertification 35 to 120 days in advance of Petitioner's reenlistment date, he would have been approved for an SRB.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's command submitted an Officer Personnel Information System (OPINS)/Navy Standard Integrated Personnel System (NSIPS) request 35 to 120 days in advance of the requested reenlistment date for the Sailor, and was it approved by cognizant authority.

Note: This change will entitle the member to a zone "A" SRB with an award level of 1.5 (\$30,000 award ceiling) for the EM rate. Remaining obligated service to 10 October 2022 will be deducted from SRB computation.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.
