1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to show his current Certificate of Release or Discharge from Active Duty (DD Form 214) block 4a (Grade, rate or rank) reflect ETN1, and block 4b (Pay grade) E-6.

2. The Board, consisting of [REDACTED], [REDACTED], and [REDACTED] reviewed Petitioner's allegations of error and injustice on 16 June 2022 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 13 July 2021, Commanding Officer, [REDACTED] notified Petitioner that per MILPERSMAN 1420-060, he was authorized to assume the title and wear the uniform of a Petty Officer First Class effective immediately. Petitioner's appointment carries with it the obligation that you exercise increased authority and willingly accept greater responsibility. Per MILPERSMAN 1420-060, Petitioner will not be entitled to pay and other monetary allowances of a First Class Petty Officer until actually advanced to the pay grade for which he had been selected.

b. On 16 December 2021, Petitioner was advanced to ETN1/E-6.

c. On 30 November 2021, Petitioner was issued a DD Form 214 with an erroneous block 4a (Grade, rate or rank) ETN2, block 4b (Pay grade) E-5, and block 12i (Effective date of pay grade) 16 December 2018 with a separation date this period of 18 January 2022.

d. On 18 January 2022, Petitioner was honorably released from active duty and transferred to the Navy Reserve.

e. On 2 June 2022, Petitioner was issued a DD Form 214 with an erroneous block 12i (Effective date of pay grade) 1 June 2022 with a separation date this period of 18 January 2022.

CONCLUSION

Upon review and consideration of all the evidence of record, the Board finds the existence of an injustice warranting the following partial corrective action. The Board concluded that during a review of Petitioner's official military personnel file, it was discovered that two DD Form 214(s) were issued for the same period during his career. The first DD Form 214 should have been expunged when the second DD Form 214 was published. Furthermore, an error was made to the second DD Form 214 that was not corrected.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's DD Form 214 issued on **30 November 2021**, executed on 18 January 2022 will be expunged from Petitioner's naval record.

Petitioner's DD Form 214 issued on **2 June 2022** executed on 18 January 2022 listed block 12i (Effective date of pay grade) 16 December 2021 vice 1 June 2022.

That part of Petitioner's request for corrective action that exceeds the foregoing be denied.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
