1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to show Petitioner's current reenlistment contract reflects U.S. Naval Reserve (Branch class 32 - Full Time Support).

2. The Board, consisting of [REDACTED], [REDACTED], and [REDACTED] reviewed Petitioner's allegations of error and injustice on 22 February 2022 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. On 10 September 2002, Petitioner enlisted in the U.S. Naval Reserve for 8 years with an expiration of obligated service (EOS) of 9 September 2002. Furthermore, he signed an Enlistment Guarantees (NAVCRUIT 1133/52) Annex "A" to DD Form 4 dated 10 September 2002 listing the following option: (4yoTEP) Electrician's Mate "A" School Program Guarantee.

c. On 1 May 2007, Petitioner reenlisted for 4 years in the U.S. Naval Reserve (Branch class 32) with a Reserve Active Duty Obligation (RADO) months/days of "048/000" vice "000/000."

d. On 20 June 2014, Petitioner reenlisted for 6 years in the U.S. Naval Reserve (Branch class 32) with a Reserve Active Duty Obligation (RADO) months/days of "072/000" vice "000/000."

e. On 6 June 2021, Petitioner erroneously reenlisted for 3 years in the U.S. Navy (Branch class 11) vice U.S. Naval Reserve (Branch class 32 - Full Time Support) with a Reserve Active Duty Obligation (RADO) months/days of "000/000" vice "036/000."

f. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that Petitioner is considered a U.S. Naval Reserve (Branch class 32 - Full Time Support); however, a review of Petitioner's Official Military Personnel File shows he erroneously reenlisted for 3 years in the U.S. Navy (Branch class 11) vice U.S. Naval Reserve (Branch class 32 - Full Time Support).

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 3-year immediate reenlistment contract (NAVPERS 1070/601) executed on 6 June 2021 was in the U.S. Naval Reserve (Branch class USNR) vice U.S. Navy (Branch class USN) and a RADO months/days of "036/000" vice "000/000".

Note: The above changes will authorize corresponding Corporate Data System updates.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.

Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)) and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of reference (a), has been approved by the Board on behalf of the Secretary of the Navy.
