1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting his record be corrected to change the date of birth listed on his discharge documents.

2. The Board consisting of █ reviewed Petitioner's allegations of error and injustice on 16 March 2022 and, pursuant to its regulations, determined that the corrective action indicated below should be taken. Documentary material considered by the Board consisted of Petitioner's application together with all material submitted in support thereof, relevant portions of Former Member's naval record, and applicable statutes, regulations, and policies..

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. Although the enclosure was not filed in a timely manner, it is in the interest of justice to review the application on its merits.

c. The Petitioner enlisted in the Navy and completed a period of honorable service from 5 August 1998 to 31 March 2006.

d. At the time of Petitioner's discharge, he was issued a Certificate of Release or Discharge from Active Duty (DD Form 214). Block 5 of Petitioner's DD Form 214 erroneously reflects his date of birth (DOB) as 11 April 1980 vice 4 November 1980.

e. Petitioner requests correction of the DOB listed on his DD Form 214 from 11 April 1980 to 4 November 1980. Petitioner provides a copy of his birth certificate, and a copy of US

Passport as evidence in support of his Petition to the Board. Both documents reflect Petitioner's DOB as 4 November 1980.

CONCLUSION:

Upon review and consideration of all the evidence of record, the Board concludes that Petitioner's request warrants favorable action. The Board notes the Petitioner's DD Form 214 incorrectly reflects Petitioner's DOB. In this regard, Petitioner's DOB should reflect 4 November 1980.

In view of the above, the Board directs the following corrective action.

RECOMMENDATION:

That Petitioner be issued a Correction to DD Form 214, Certificate of Release or Discharge from Active Duty (DD Form 215) which reflects correction of Petitioner's DOB from 11 April 1980 to 4 November 1980.

That a copy of this Report of Proceedings be filed in Petitioner's Naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulation, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.]
