3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. On 16 March 1962, Petitioner enlisted for 6 years in the U.S. Marine Corps Resrve with an End of Obligated Service of 15 March 1968.

c. On 3 April 1962, Petitioner entered active duty for 3 years with an End of Current Contract of 2 April 1965.

d. On 2 April 1965, Petitioner was honorably released from active duty and transferred to the U.S. Marine Corps Reserve.

e. On 15 March 1968, Petitioner was discharged from the U.S. Marine Corps Resrve.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of reference (b)¹, the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that the Petitioner served on active duty from 3 April 1962 to 2 April 1965, however, due to clerical error, his DD Form 214 lists his date of entry as 3 April 1965.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

The Armed Forces of the United States Report of Transfer or Discharge (DD Form 214) executed on 2 April 1965 list block 19c (date of entry) "3 April 1962" vice "3 April 1965".

That no further changes be made to Petitioner's naval record.

That a copy of this report of proceedings be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
