1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to include service from 26 June 1985 through 29 October 1990 on his Certificate of Release or Discharge from Active Duty (DD Form 214) ending on 29 March 1993.

2. The Board, consisting of [REDACTED], [REDACTED], and [REDACTED] reviewed Petitioner's allegations of error and injustice on 20 October 2022 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, he exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings:

a. On 26 June 1979 Petitioner enlisted in the U.S. Marine Corps (USMC) Reserve for a term of 6 years of which 3 years was an obligation in the regular component, and entered active duty on 17 June 1980.

b. On 18 April 1983 Petitioner reenlisted for a term of 3 years in the USMC. The Petitioner's official military personnel file does not contain a DD Form 214 for the active duty period of 17 June 1980 through 17 April 1983.

c. On 30 September 1985 Petitioner discharged and issued DD Form 214 for the active duty period of 18 April 1983 to 30 September 1985, and reenlisted for a term of 4 years on 1 October 1985—thereafter, Petitioner executed five (5) separate contract extensions.

d. On 30 October 1990 Petitioner reenlisted for a term of 2 years in the USMC.

e. On 29 March 1993 Petitioner discharged and issued DD Form 214 for the active duty period of 30 October 1990 through 29 March 1993.

CONCLUSION

Upon review and consideration of all the evidence of record, the Board finds the existence of an injustice warranting the following corrective action. The Board concluded there is no evidence Petitioner issued DD Form 214 for active duty service of 17 June 1980 through 17 April 1983. Additionally, Petitioner's DD Form 214 dated 29 March 1993 did not include active duty service from 1 October 1985 through 29 October 1990. Therefore, the Board felt, under these circumstances, partial relief warranted.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner issued DD Form 214 for the period of 17 June 1980 through 17 April 1983.

Petitioner issued DD Form 215, Correction to DD Form 214 ending on 29 March 1993 modifying Block 12a to reflect "851001" vice "901030"; appropriate adjustment to Blocks 12c, and 12d; and any other Blocks as required.

The part of Petitioner's request for corrective action that exceeds the foregoing is denied in accordance with reference (b).¹

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.
5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
