1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, a former enlisted member of the Navy, filed enclosure (1) with this Board requesting, in effect, that his characterization of service Other Than Honorable (OTH) and narrative reason for separation "Homosexuality" be changed per reference (b). Enclosures (1) through (3) apply.

2. The Board, consisting of ██████████, and ██████████, reviewed Petitioner's allegations of error and injustice on 29 June 2022 and, pursuant to its regulations, determined that the corrective action indicated below should be taken. Documentary material considered by the Board consisted of Petitioner's application together with all material submitted in support thereof, relevant portions of Petitioner's naval record, applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. Although enclosure (1) was not filed in a timely manner, it is in the interest of justice to waive the statute of limitations and review the application on its merits.

c. Petitioner entered active duty with the Navy on 25 February 1964. On 15 September 1965, Petitioner made a written statement admitted to being a homosexual and committing sexual acts with people of the same sex while on active duty. On 5 November 1965, Petitioner made an additional statement confirming his homosexuality. Subsequently, Petitioner was notified of pending administrative separation action by reason of homosexuality. After waiving his

procedural rights, Petitioner's commanding officer (CO) forwarded his package to the separation authority (SA) recommending his discharge by reason of homosexuality, with an OTH characterization of service. The SA approved the recommendation and, on 3 December 1965, Petitioner was discharged with an OTH characterization of service by reason of homosexuality. Petitioner's final conduct and proficiency marks averaged 3.4 for his enlistment period.

d. Petitioner contends that his characterization of service and narrative reason for separation was based solely on him admitting to being a homosexual.

e. Reference (c) sets forth the Department of the Navy's current policies, standards, and procedures for correction of military records following the "don't ask, don't tell" (DADT) repeal of 10 U.S.C. 654. It provides service Discharge Review Boards with the guidance to grant requests to change the characterization of service to "Honorable," narrative reason for separation to "Secretarial Authority," SPD code to "JFF," and reenry code to "RE-1J," when the original discharge was based solely on DADT or a similar policy in place prior to enactment of it and there are no aggravating factors in the record, such as misconduct.

CONCLUSION:

Upon review and consideration of all the evidence of record, and especially in light of reference (b) and (c), the Board concludes that Petitioner's request warrants relief. In this regard, the Board noted that Petitioner was separated solely on his homosexuality. As a result, he was assigned an OTH characterization despite conduct and proficiency marks that qualified for an Honorable characterization of service. In reviewing Petitioner record, the Board found no aggravating factors to disqualifying him from receiving the benefit of the reference (c). Therefore, relief in the form of changes to his characterization of service, narrative reason for separation, separation code, separation authority, and reenlistment code are appropriate.

In view of the foregoing, the Board directs the following partial corrective action.

RECOMMENDATION:

That Petitioner's record be corrected to show that, on 3 December 1965, his characterization of service was "Honorable", his narrative reason for separation was "Secretarial Authority," reenlistment code was "RE-1J," SPD code was "JFF1," and his separation authority was "MILPERSMAN 1910-164".

That no further changes be made to the record.

That a copy of this report of proceedings be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulation, Section 723.6(e)) and having assured compliance with its provisions, it is hereby announced that the foregoing
