1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to establish Petitioner's effective date of BUPERS Order 3331 (Official Separation Orders) to a date acceptable for Personally Procured Move (PPM) of Household Goods (HHG) shipment claim processing and payment per reference (b).

2. The Board, consisting of [REDACTED], [REDACTED], and [REDACTED] reviewed Petitioner's allegations of error and injustice on 19 May 2022 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, he exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings:

a. On 16 October 2021 Petitioner executes HHG PPM per NAVSUP Fleet Logistics Center Norfolk letter of 28 May 2022.

b. On 19 November 2021 Petitioner honorably discharged upon completion of required active service and issued DD Form 214. Petitioner's Electronic Service Record NSIPS History of Assignments reflect discharge effective this date.

c. On 29 November 2021 Petitioner issued BUPERS Order 3331 (Official Separation Orders) for separation effective 30 November 2021.

#### CONCLUSION

Upon review and consideration of all the evidence of record, the Board finds the existence of an injustice warranting the following corrective action. The Board concluded the Petitioner should have received his separations orders before he was separated in order to move his HHG, therefore, his orders should reflect that his orders were issued in time to execute his HHG shipment.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

BUPERS Order 3331 (Official Separation Orders) issued 15 October 2021 vice 29 November 2021. Petitioner authorized to submit Household Goods (HHG) claim utilizing funding from BUPERS Order 3331.
