Subj: REVIEW NAVAL RECORD OF FORMER MEMBER XXX-XX-USMC

1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, a former enlisted member of the Marine Corps, filed enclosure (1) with this Board requesting, in effect, that her characterization of service General (Under Honorable Conditions) and narrative reason for separation "Homosexuality" be changed per reference (b). Enclosures (1) through (3) apply.

2. The Board, consisting of **Construction**, **Construction**, and **Construction**, reviewed Petitioner's allegations of error and injustice on 1 June 2022 and, pursuant to its regulations, determined that the corrective action indicated below should be taken. Documentary material considered by the Board consisted of Petitioner's application together with all material submitted in support thereof, relevant portions of Petitioner's naval record, applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. Although enclosure (1) was not filed in a timely manner, it is in the interest of justice to waive the statute of limitations and review the application on its merits.

c. After a period of honorable service, Petitioner reenlisted in the Marine Corps in March 1987. On 12 June 1989, Petitioner made a written statement admitted to being a homosexual and committing sexual acts with people of the same sex while on active duty. On 13 June 1989, Naval Investigative Service (NIS) confirmed Petitioner was a homosexual and engaging in sexual

relations with members of the same sex while on active duty in the Marine Corps. Subsequently, Petitioner was notified of pending administrative separation action by reason of homosexuality. After waiving her procedural rights, Petitioner's commanding officer (CO) forwarded her package to the separation authority (SA) recommending her discharge by reason of homosexuality, with a General (Under Honorable Conditions) characterization of service. The SA approved the recommendation, and on 28 September 1989, Petitioner was discharged with a General (Under Honorable Conditions) characterization of service by reason of homosexuality. Petitioner's final conduct and proficiency marks exceeded 4.0 for her enlistment period.

d. Petitioner contends that her characterization of service and narrative reason for separation was based solely on him admitting to being a homosexual.

e. Reference (c) sets forth the Department of the Navy's current policies, standards, and procedures for correction of military records following the "don't ask, don't tell" (DADT) repeal of 10 U.S.C. 654. It provides service Discharge Review Boards with the guidance to grant requests to change the characterization of service to "honorable," narrative reason for separation to "secretarial authority," SPD code to "JFF," and reentry code to "RE-1J," when the original discharge was based solely on DADT or a similar policy in place prior to enactment of it and there are no aggravating factors in the record, such as misconduct.

CONCLUSION:

Upon review and consideration of all the evidence of record, and especially in light of reference (b) and (c), the Board concludes that Petitioner's request warrants relief. In this regard, the Board noted that Petitioner was separated solely on her homosexuality and assigned a General (Under Honorable Conditions) characterization despite conduct and proficiency marks that qualified for an Honorable characterization. Therefore, relief in the form of changes to her characterization of service, narrative reason for separation, separation code, separation authority, and reenlistment code are appropriate.

In view of the foregoing, the Board directs the following partial corrective action.

RECOMMENDATION:

That Petitioner's record be corrected to show that on 28 September 1989, her characterization of service was "Honorable", her narrative reason for separation was "Secretarial Authority," reenlistment code was "RE-1J," SPD code was "JFF1," and her separation authority was "MARCORSEPMAN 6214".

That no further changes be made to the record.

That a copy of this report of proceedings be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.
