1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that her naval record be corrected to change block 12a of the Certificate of Release or Discharge from Active Duty (DD Form 214) ending on 31 July 2001.

2. The Board, consisting of [REDACTED], reviewed Petitioner's allegations of error and injustice on 16 August 2022 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. On 21 July 1981 Petitioner entered active duty for 4 years with an end of active obligated service (EAOS) of 20 July 1985, and was discharged with an honorable character of service and was issued a DD Form 214 for the period of 21 July 1981 to 13 June 1985 within three months of expiration of enlistment.

b. On 14 June 1985 Petitioner reenlisted for 6 years with an EAOS of 13 June 1991, and on 15 June 1990 reenlisted for 6 years with an EAOS of 14 June 1996.

c. On 4 August 1992 Petitioner signed an agreement to extend enlistment for 36 months with a SEAOS of 14 June 1999, and on 5 April 1996 reenlisted for 5 years with an EAOS of 4 April 2001.

d. On 27 February 2001 Petitioner signed an agreement to extend enlistment for 4 months with a SEAOS of 4 August 2001, and was transferred to the Fleet Reserve with an honorable character of service and was issued a DD Form 214 for the period of 15 June 1985 to 31 July 2001 upon having sufficient service for retirement.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of reference (b),¹ the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that prior to 28 June 1993, a DD Form 214 was issued to service members discharged for the purpose of immediate enlistment or reenlistment. Petitioner was issued a DD Form 214 upon her reenlistment on 14 June 1985. Petitioner should have been issued a DD Form 214 upon her reenlistment on 15 June 1990. Petitioner's DD Form 214 ending on 31 July 2001 should list "15 June 1990" vice "15 June 1985" in block 12a (Date entered active duty (AD) this period)).

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner was issued a DD Form 214 for the period of 14 June 1985 to 14 June 1990.

The Certificate of Release or Discharge from Active duty (DD Form 214) ending on 31 July 2001 listed block 12a (Date entered AD this period) "15 June 1990" vice "15 June 1985." Note: That any other entries affected by the Board's recommendation be corrected.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.

¹ Reference (b), the DD Form 214 is prepared to cover periods of service on active duty, temporary active duty, some periods of active duty for training, certain periods terminated by a change of status not concurrent with separation from active service, and release from a status that is legally determined to be void. The DD Form 214 will be prepared and furnished to members while serving on active duty when they have a change of status or component as follows: Discharged for the purpose of immediate enlistment or reenlistment.

Reference (c), the DD 214 is prepared to cover periods of service on active duty, active duty for training, full-time training duty, active duty for special work, certain periods terminated by a change of status not concurrent with separation from active service, and release from a status that is legally determined to be void. The DD 214 will not be prepared or issued in the case of personnel: Who are discharged for immediate enlistment or reenlistment.
