CONCLUSION

Upon review and consideration of all the evidence of record, the Board finds the existence of an injustice warranting the following corrective action. The Board concluded per reference (b) HHG allowances are based on the when orders are effective and certain criteria must be met in order to execute HHG transportation before an order is issued. The Petitioner failed to meet the requirements and began execution of HHG shipment prior to issuance of orders. To eliminate financial burden for the Petitioner relief is granted.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's BUPERS Order 0911 (Official Separation Orders) issued 26 March 2021 vice 26 April 2021. Petitioner authorized to submit Household Goods (HHG) claim utilizing funding from BUPERS Order 0911.
