was bo	Subject married on 26 September 1969 and first child, on 24 March 1987—SBP Former coverage was not ordered.			
b. Subject married Petitioner, on 9 May 1987 and has two additional children: born on 21 January 1994 and born 21 June 1995. On 2 February 1998, Subject signed DD Form 2656, Data for Payment of Retired Personnel, electing SBP Spouse and Children coverage. Petitioner transferred to the Retired List effective 1 November 1998. Subject divorced Petitioner on 17 June 2002. Final Decree incorporated Property Settlement Agreement of 27 March 2001 which directed SBP Former Spouse coverage.				
	c. Subject married on 1 October 2003 and divorced on 9 May 2014—SBP ormer Spouse coverage was not ordered.			

- d. Petitioner married her second spouse on 26 June 2004 at age 49.
- e. Subject passed away on 20 February 2017.
- f. Petitioner divorced her second spouse on 19 June 2017.
- g. On 30 May 2019, Petitioner submitted a request to Defense Finance and Accounting Service (DFAS) for receive SBP annuity; DFAS denied the request on 19 July 2019 because Subject "did not make a request to change his election to former spouse coverage nor was a deemed election for former spouse coverage made by you."
- h. On 10 June 2022, DFAS confirmed "At retirement member was paying spouse and child costs. He went to child only at his divorce of 6/17/2002 and continued paying child costs up until death. He was 220 payments paid in SBP. No SBP costs were refunded in AOP."

CONCLUSION

Upon review and consideration of all the evidence of record, the Board finds the existence of an injustice warranting the following corrective action. The Board concluded Subject failed to change his SBP coverage from Spouse to Former Spouse as directed by the Final Decree of Divorce and in accordance with reference (b)¹. Although Subject did not complete the proper administrative requirements, the Board felt that under these circumstances, relief is warranted.

RECOMMENDATION

That Subject's naval record be corrected, where appropriate, to show that:

Subject elected to change SBP coverage from "Spouse and Children" to "Former Spouse" naming as the beneficiary, at the same level of coverage as previously elected within 1-year of divorce on 17 June 2002.

Note: No waiver of unpaid premiums will be granted.

Defense Finance and Accounting Service will complete an audit of Subject's pay records to determine Petitioner's retroactive SBP annuity entitlement. Note: Petitioner was married from 26 June 2004 through 19 June 2017.

That no further changes be made to Petitioner's naval record.

That a copy of this report of proceedings be filed in Petitioner's naval record.

¹ Reference (b), a member with spouse or spouse and child coverage may, within 1 year of date of the decree of divorce, dissolution, or annulment, whichever is later, change that election to provide an annuity to a former spouse or to a former spouse and child. If such member fails or refuses to make such election, the member is deemed to have made such election if the Secretary concerned receives a completed DD Form 2656-10, SBP Former Spouse Request for Deemed Election, from a former spouse or the former spouse's attorney on behalf of the former spouse. Election or deemed election must be received within 1-year from the date of divorce.
