1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to show Petitioner's Certificate of Release or Discharge from Active Duty (DD Form 214) block 12c (Net active service this period) was 10 years and 1 month vice 10 years and 29 days.

2. The Board, consisting of [REDACTED], [REDACTED], and [REDACTED] reviewed Petitioner's allegations of error and injustice on 16 June 2022 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. On 23 September 1986, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 22 September 1990 and Soft End of Active Obligated Service of 22 September 1992.

c. On 23 October 1990, Petitioner entered active duty for 6 years with an EAOS of 22 October 1996.

d. In accordance with reference (b), DD Form 214, Block 12c (Net active service this period). Enter the years, months, and days of net service this period. Note that service while

attending a service academy as a midshipman, USN, or as a cadet is creditable for enlisted members reverted to enlisted status, but in no case is it creditable for warrant or commissioned officer.

e. In accordance with reference (c), for each non-continuous period of service, add 1 day to account for inclusive days. Explanation: Any period of service is at least one day. If, for example, the member had one day of service on January 17, 2016, the computation would look like this: 0 years, 0 months, and 0 days. It is necessary to add 1 day for inclusive days to avoid this erroneous answer.

f. Petitioner was honorably discharged and was issued a DD Form 214 for the period of 23 September 1986 to 22 October 1996 upon completion of required active service with 10 years, and 29 days.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that an administrative error occurred in the calculation of Petitioner's total service, omitting an inclusive date.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's DD Form 214 effective 22 October 1996 block 12c (Net active service this period) was 10 years and 1 month vice 10 years and 29 days. Note: That any other entries affected by the Board's recommendation be corrected.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
