1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to establish entitlement to a Zone "B" Selective Reenlistment Bonus (SRB).

2. The Board, consisting of ██████████, ██████████, and ██████████ reviewed Petitioner's allegations of error and injustice on 30 June 2022 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, he exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings:

a. Petitioner's Active Duty Service Date is 10 July 2013.

b. On 25 January 2019, Petitioner reenlisted for a term of 4 years with an end of active obligated service (EAOS) of 24 January 2023.

c. On 11 April 2022, Petitioner issued BUPERS Order: 1012 (Official Change Duty Orders 1012) with an obligated service requirement to November 2027. Thereafter, Petitioner issued order medications on 20 April 2022 and 15 June 2022. On 6 May 2022, Petitioner submitted NPPSC 1160/1, Command Career Request to reenlist on 13 May 2022 for a term of 6 years to "OBLISERV" for orders; Officer-in-Charge, ██████████ approved the request the same day. On 13 May 2022, Petitioner reenlisted for a term of 6 years with an EAOS of 12 May 2028.

d. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that at the time Petitioner submitted his reenlistment request there was no SRB available for his rating/Zone. However, reference (b)¹ published the day of Petitioner's reenlistment and outlined eligibility for [REDACTED] in Zone "B." Therefore, the Board felt, under these circumstances, relief is warranted.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Bureau of Naval Personnel (BUPERS-328) approved a 35-day waiver for Petitioner to reenlist on 13 May 2022 for a term of 6-year and receive a Zone "B" SRB.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of 0.5 (\$30,000 award ceiling) for the [REDACTED] rating.

That no further changes be made to Petitioner's naval record.

That a copy of this report of proceedings be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
