(2) Case Summary

1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that her naval record be corrected by reflecting an accurate social security number (SSN) on her Certificate of Release or Discharge from Active Duty (DD Form 214).

2. The Board consisting of ██████████, ██████████, and ██████████ reviewed Petitioner's allegation of injustice on 30 June 2022 and, pursuant to its regulations, determined the corrective action indicated below should be taken. Documentary material considered by the Board consisted of Petitioner's application together with all material submitted in support thereof, relevant portions of Petitioner's naval record, applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. Although enclosure (1) was not filed in a timely manner, it is in the interests of justice to review Petitioner's application on its merits.

c. Petitioner enlisted and began a period of active duty in the Navy on 30 March 1998. At the time of her enlistment, her SSN was verified as ██████████. On 11 September 1998, she was discharged with an uncharacterized character of service.

d. On 6 November 2000, Petitioner was issued a new DD Form 214 in accordance with the Naval Discharge Review Board's decision to change her narrative reason for separation. The newly issued DD Form 214 incorrectly indicated her SSN as ██████████.

e. On 1 December 2000, Petitioner was issued a Correction to DD Form 214, Certificate of Release or Discharge from Active Duty (DD Form 215) correcting the SSN on block three of her DD Form 214. However, the SSN in the identifying information was still incorrect.

f. Petitioner submitted a copy of her social security card indicating her SSN as [REDACTED]-

CONCLUSION:

Upon review and consideration of all the evidence of record, the Board concludes Petitioner's request warrants relief.

The Board noted that Petitioner's enlistment contract and social security card indicate her SSN as [REDACTED].

RECOMMENDATION:

In view of the above, the Board directs the following corrective action:

Petitioner be issued a new DD Form 215 that accurately reflects her SSN as [REDACTED] in both the identifying information and the "corrected to read" section of the form.

That no further changes be made to Petitioner's record.

A copy of this report of proceedings be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of reference (a), has been approved by the Board on behalf of the Secretary of the Navy.
