1. Pursuant to the provisions of the reference, Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting to correct enclosure (2).
2. The Board, consisting of [REDACTED] reviewed Petitioner's allegations of error and injustice on 26 July 2022 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval records, and applicable statutes, regulations, and policies, to include the advisory opinion (AO), enclosure (3).
3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
  - a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
  - b. Petitioner was issued a certified copy of her Periodic/Regular evaluation report for the reporting period 16 July 2020 to 15 June 2021. See enclosure (2).
  - c. Petitioner contends that block 2 of the evaluation report contains an error. Block 2 of the evaluation report reflects Petitioner's rate as BM3 instead of BMSN. Petitioner explained that she was to be promoted to boatswain mate 3 (BM3/E-4), but was not eligible. Petitioner claims that she has spent more than a year trying to correct the error through her chain of command and she cannot be advanced in rank until the evaluation report is corrected. See enclosure (1).
  - d. In the AO furnished by the Navy Personnel Command (PERS-32), the AO recommended granting relief. The AO confirmed that Petitioner was not advanced to BM3 and that block 2 of

the evaluation report appears to be in error. The AO noted that Petitioner has exhausted all means to have the evaluation report corrected, therefore, PERS-32 has no objection to correcting block 2. See enclosure (3).

#### CONCLUSION

Upon review and consideration of all the evidence of record, the Board found the existence of an error warranting corrective action.

The Board substantially concurred with the AO. In this regard, the Board noted PERS-32 confirmed Petitioner was not advanced to BM3 and her rate at the close of the reporting period was BMSN. Based upon the foregoing, the Board determined block 2 of enclosure (2) should be changed to reflect BMSN.

#### RECOMMENDATION

In view of the above, the Board directs the following corrective action:

Petitioner's naval record be corrected by changing block 2 of enclosure (2) to BMSN.

That no further changes be made to Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of reference (a), has been approved by the Board on behalf of the Secretary of the Navy.
