1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be reviewed for possible corrections to Petitioner's Certificates of Release or Discharge from Active duty (DD Form 214) effective 2 April 1993 and 31 October 2011.

2. The Board, consisting of [REDACTED], [REDACTED], and [REDACTED], reviewed Petitioner's allegations of error and injustice on 4 August 2022 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. On 14 February 1989, Petitioner enlisted for 8 years in the U.S. Naval Reserve with an Expiration of Obligated Service of 13 February 1997.

c. On 3 April 1989, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 2 April 1993.

d. Petitioner was released from active duty and transferred to the Naval Reserve with a Honorable character of service and was issued a DD Form 214 for the period of 3 April 1989 to 2 April 1993 upon release from active duty and transfer to the Naval Reserve.

e. On 26 October 1995, Petitioner entered active duty for 4 years with an EAOS of 25 October 1999.

f. On 28 June 1999, Petitioner signed an agreement to extend enlistment for 8 months with a Soft End of Active Obligated Service (SEAOS) of 25 June 2000 in order to match Projected Rotation Date (PRD) to EAOS.

g. On 1 May 2000, Petitioner reenlisted for 2 years with an EAOS of 30 April 2002.

h. On 24 May 2000, Petitioner signed an agreement to extend enlistment for 3 months with a SEAOS of 31 July 2002 in order to meet OBLISERV for BUPERS order 3079.

i. On 9 April 2002, Petitioner signed an agreement to extend enlistment for 12 months with a SEAOS of 31 July 2003 in order to match EAOS and PRD of July 2003.

j. On 12 March 2003, Petitioner reenlisted for 4 years with an EAOS of 11 March 2007 and SEAOS of 11 November 2007

k. On 10 September 2007, Petitioner signed an agreement to extend enlistment for 10 months with a SEAOS of 11 September 2008 in order to match EAOS and PRD.

l. On 5 September 2008, Petitioner reenlisted for 3 years with an EAOS of 4 September 2011.

m. In accordance with reference (b), the date entered in block 12a shall be the date of enlistment for the earliest period of continuous active service for which a DD 214 was not previously issued.

n. Petitioner was released from active duty and transferred to the Fleet Reserve with a Honorable character of service and was issued a DD Form 214 for the period of 3 April 1989 to 31 October 2011 upon having sufficient service for retirement.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that initially Petitioner completed 4 years of active service effective 2 April 1993. On 26 October 1995, Petitioner entered active duty, however, Petitioner's DD Form 214 effective 31 October 2011 erroneously lists 3 April 1989 in block 12a (date entered active duty this period).

Furthermore, a review of Petitioner's Pay Entry Base Date (PEBD) and Active Duty Service Date (ADSD) revealed that the PEBD may be erroneous. Petitioner entered active duty on 3 April 1989 and served continuously in the active and inactive service until his retirement on 31 October 2011.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

The Certificate of Release or Discharge from Active duty (DD Form 214) executed on 31 October 2011 listed block 12a (date entered active duty this period) "26 October 1995" vice "3 April 1989". Note: That any other entries affected by the Board's recommendation be corrected.

That no further changes be made to Petitioner's naval record.

That a copy of this report of proceedings be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
