- 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting his record be corrected to change the social security number listed on his discharge documents.
- 2. The Board, consisting of _____, and ____, and ____, reviewed Petitioner's allegations of error and injustice on 19 September 2022 and, pursuant to its regulations, determined that the corrective action indicated below should be taken. Documentary material considered by the Board consisted of Petitioner's application together with all material submitted in support thereof, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies..
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:
- a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
- b. Although the enclosure was not filed in a timely manner, it is in the interest of justice to review the application on its merits.

e. Petitioner is requesting that his social security number listed on his DD Form 214 be change from XXX-XX- to XXX-XX- He is requesting this correction to be done before he can apply for Department of Veterans Affairs benefits.

CONCLUSION:

Upon review and consideration of all the evidence of record, the Board determined that the Petitioner's request warrants favorable action. The Board notes the Petitioner's DD Form 214 incorrectly reflect his social security number as XXX-XX vice XXX-XX. In this regard, the Board determined there is an administrative error on the Petitioner's naval record.

In view of the above, the Board directs the following corrective action.

RECOMMENDATION:

That Petitioner be issued a Correction to Certificate of Release or Discharge from Active Duty DD Form 214 (DD Form 215) reflecting his correct social security number of XXX-XX-

That a copy of this Report of Proceedings be filed in Petitioner's Naval record.
