1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting his record be corrected to change the social security number (SSN) listed on his discharge documents.

2. The Board, consisting of ██████████, ██████████, and ██████████, reviewed Petitioner's allegations of error and injustice on 17 August 2022 and, pursuant to its regulations, determined that the corrective action indicated below should be taken. Documentary material considered by the Board consisted of Petitioner's application together with all material submitted in support thereof, relevant portions of Former Member's naval record, and applicable statutes, regulations, and policies..

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. Although the enclosure was not filed in a timely manner, it is in the interest of justice to review the application on its merits.

c. Petitioner enlisted in the Navy and completed a period of honorable service from 23 June 1959 to 11 April 1963.

d. Upon his discharge, Petitioner was issued an Armed Forces of the United States Report of Transfer or Discharge (DD Form 214). Block 32 of Petitioner's DD Form 214 lists his SSN as ██████████ despite his enlistment records listing his SSN as ██████████.

e. Petitioner requests correction of the social security number listed on his DD Form 214 from [REDACTED] to [REDACTED]. Petitioner provided a copy of his social security card that documents his SSN as [REDACTED].

CONCLUSION:

Upon review and consideration of all the evidence of record, the Board concludes that Petitioner's request warrants favorable action. The Board notes all documents in Petitioner's record reflect [REDACTED] as his SSN. The Board determined there to be sufficient evidence to identify an administrative error on Petitioner DD Form 214. In this regard, Petitioner's SSN should reflect [REDACTED] on his discharge documents.

In view of the above, the Board directs the following corrective action.

RECOMMENDATION:

That Petitioner be issued a Correction to Certificate of Release or Discharge From Active Duty DD Form 214 (DD Form 215) indicating his SSN as [REDACTED]

That a copy of this Report of Proceedings be filed in Petitioner's Naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulation, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.]
