1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected show Petitioner's Certificate of Release or Discharge from Active Duty (DD Form 214) block 29 reflect "13 December 1985 to 30 December 1985" vice "13 December 1985 to 30 December 1989".

2. The Board, consisting of [REDACTED] reviewed Petitioner's allegations of error and injustice on 25 October 2022 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. On 14 December 1983 Petitioner enlisted in the U.S. Naval Reserve for 6 years with an expiration of obligated service of 13 December 1989.

b. On 12 December 1984 Petitioner entered active duty for 4 years with an end of active obligated service (EAOS) of 11 December 1988.

c. Petitioner was unauthorized absence (UA) status from Naval Hospital, [REDACTED] and was issued a Record of Unauthorized Absence for the period of 13 December 1985 to 30 December 1985 upon returning to [REDACTED].

d. On 27 December 1988 Petitioner signed an agreement to extend enlistment for 12 months with an soft end of active obligated service of 28 December 1989 in order to incur sufficient obligated service for EAOS and Projected Rotation Date to coincide.

e. Petitioner was released from active duty and transferred to the Navy Reserve with an honorable character of service and was issued a DD Form 214 for the period of 12 December 1984 to 28 December 1989 upon completion of required active service. Furthermore, block 29 (Dates of time lost during this period) listed 13 December 1985 to 30 December 1989.

f. On 22 December 1990 Petitioner was honorably discharged from the U.S. Naval Reserve.

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of reference (b)<sup>1</sup> and enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that Petitioner was reported to be in a UA status on 13 December 1985 and was returned to military control on 30 December 1985; however, the DD Form 214, block 29 erroneously lists the return date to military control as 1989 vice 1985 and should be corrected.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

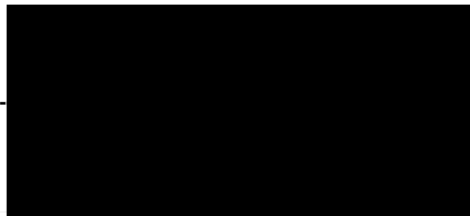
Petitioner's DD Form 214 executed on 28 December 1989, block 29 (Dates of time lost during this period) listed TL "13 December 1985 to 30 December 1985" vice "13 December 1985 to 30 December 1989." Note: That any other entries affected by the Board's recommendation be corrected.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.

<sup>1</sup> Reference (b), The DD Form 214 is prepared to cover periods of service on active duty, temporary active duty, some periods of active duty for training, certain periods terminated by a change of status not concurrent with separation from active service, and release from a status that is legally determined to be void. Block 29, Dates of Time Lost during this period. Enter inclusive dates for all periods of time lost during this period. Include periods of unauthorized absence, sickness due to misconduct, confinement, and non-performance of duty due to civil arrest, but do not identify types of time lost other than by "TL".
