- 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to show that Petitioner's Certificate of Release or Discharge from Active Duty (DD Form 214) executed on 30 June 1997 block 12a (Date Entered Active Duty This Period) reflect 20 June 1977 vice 3 January 1986.
- 2. The Board, consisting of reviewed Petitioner's allegations of error and injustice on 22 September 2022 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
- a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
- b. On 20 June 1977, Petitioner entered active duty for 4 years with an end of active obligated service (EAOS) of 19 June 1981.
- c. On 21 January 1981, Petitioner signed an agreement to extend enlistment for 12 months with an soft end of active obligated Service of 19 June 1982.
 - d. On 28 May 1981, Petitioner reenlisted for 4 years with an EAOS of 27 May 1985.
- e. Petitioner was discharged with an Honorable character of service and was issued a DD Form 214 for the period of 28 May 1981 to 2 January 1986 for immediate reenlistment.
- f. Petitioner was transferred to Fleet Reserve with an Honorable character of service and was issued a DD Form 214 for the period of 3 January 1986 to 30 June 1997 upon having sufficient service for retirement with 20 years and 11 days.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of reference (b)¹ and enclosure (2), the Board finds the existence of an injustice warranting the following partial corrective action. The Board concluded that in accordance with reference (b), the Petitioner should have been issued a DD Form 214 upon his reenlistment on 28 May 1981 for active duty served from 20 June 1977 to 27 May 1981. Petitioner's DD Form 214 executed on 30 June 1997 includes all periods of active service with a total of 20 years and 11 days and no change is warranted.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner was issued a DD Form 214 for the period of "20 June 1977" to "27 May 1981" due to immediate reenlistment.

That part of the Petitioner's request for corrective action that exceeds the foregoing be denied.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

- 4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.
- 5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
