1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to establish eligibility to transfer Post-9/11 GI Bill¹ education benefits to his eligible dependent.

2. The Board, consisting of █, █, and █ reviewed Petitioner's allegations of error and injustice on 5 October 2022, and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies, to include reference (b).²

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, he exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings:

a. Petitioner's Pay Entry Base Date was 18 October 1994.

b. Petitioner reenlisted on 13 May 2008 for a term of 6-years and on 2 May 2014 for 2 years.

c. On 5 October 2014, "4 Year Service Obligation for Transfer of Post 9-11 GI-Bill Benefits" NAVPERS 1070/613, Administrative Remarks was uploaded to Petitioner's electronic service record and verified the same day.

¹ The Post-9/11 Veterans Educational Assistance Act (Post-9/11 GI Bill, Public Law 110-252) was signed into law on 30 June 2008 and became effective on 1 August 2009. The bill provides financial support for education and housing for service members with at least 90 days of service on or after 11 September 2001. The act also includes provision for qualifying service members to transfer education benefits to their eligible dependents. General descriptions of the essential components of the law were widely available beginning in summer 2008 but specific implementing guidance was not published until summer 2009.

² Reference (b), an individual may not add dependents after retirement or separation from the Armed Forces, but may modify or revoke transferred entitlement for existing designated dependents.

d. Petitioner submitted TEB applications on 19 January 2015 and 25 January 2015. The Service denied the applications on 20 January 2015 and 26 January 2015, indicating, "Petitioner has not committed additional service."

e. Petitioner submitted TEB application on 14 June 2016. The Service approved the application with an obligation end date (OED) of 30 October 2017 and later adjusted the OED to 28 February 2017.

f. Petitioner transferred to the Voluntary Training Unit effective 1 March 2017.

g. Petitioner transferred to the Retired Reserve without pay effective 1 December 2017.

CONCLUSION

Upon review and consideration of all the evidence of record, the Board finds the existence of an injustice warranting the following corrective action. Petitioner was approved to transfer Post-9/11 GI Bill education benefits; however, he failed to allocate benefits to each of dependents prior to retiring. Although Petitioner did not complete the proper administrative requirements, the Board found that had he received clear counseling from his command regarding the inability to redistribute the education benefits upon retiring, he would have taken the appropriate action prior to retirement.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner elected to change allocation of unused education benefits to [REDACTED] 36-months through the MilConnect TEB portal prior to transferring to the Retired Reserve effective 1 December 2017.

Note: Commander, Navy Reserve Forces Command (N1) will ensure Petitioner's Benefits for Education Administrative Services Tool Family Member History is updated with the aforementioned approved allocation of education benefits.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
