1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to make an administrative change to his DD Form 214 to reflect his correct first and middle names.

2. The Board, consisting of ██████████, ██████████, and ██████████, reviewed Petitioner's allegations of error and injustice on 9 November 2022, and, pursuant to its regulations, determined that the corrective action indicated below should be taken. Documentary material considered by the Board consisted of Petitioner's application together with all material submitted in support thereof, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies, to include reference (b).

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. Although enclosure (1) was not filed in a timely manner, it is in the interests of justice to review the application on its merits.

c. The Petitioner originally enlisted in the U.S. Navy Reserve (USNR) and began a period of active service on 29 August 1972. At the completion of his active obligated service, on 28 February 1973 Petitioner was discharged with an Honorable characterization of service and assigned an RE-1 reentry code. The name as it appeared on his DD Form 214N was --"██████████.██████████".

d. On 25 July 1978, at the completion of Petitioner's USNR obligated service, Petitioner was discharged with an Honorable characterization of service and recommended for reenlistment. In lieu of a DD Form 214, Petitioner was issued a "Record of Discharge from the U.S. Naval Reserve (Inactive)" (NAVPERS 1070/615 (Inactive)).

e. The full name as reflected on Petitioner's NAVPERS 1070/615 (Inactive) was somehow changed to "[REDACTED]." This erroneous name also appeared on Petitioner's Honorable Discharge Certificate (DD 256N). However, the Petitioner provided a copy of his original DD Form 214N and a current [REDACTED] driver license reflecting his correct name of "[REDACTED]."

CONCLUSION:

Upon review and consideration of all the evidence of record, the Board concluded that Petitioner's request warrants relief. The Board determined that Petitioner's record contains an error with his name on his NAVPERS 1070/615 and DD 256N.

RECOMMENDATION:

In view of the foregoing, the Board finds the existence of a material error warranting the following corrective action.

That Petitioner be issued a new NAVPERS 1070/615 (Inactive) that reflects the following change: Petitioner's name be changed to "[REDACTED]" in lieu of the incorrect name.

That Petitioner be issued a new honorable discharge certificate in the name of [REDACTED] reflecting a discharge date of 25 July 1978.

That a copy of this report of proceedings be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of reference (a), has been approved by the Board on behalf of the Secretary of the Navy.
