1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to make certain conforming changes to his DD Form 214 to reflect current military directives and policy.		
2. The Board, consisting of, and, reviewed Petitioner's allegations of error and injustice on 30 September 2022, and, pursuant to its regulations, determined that the corrective action indicated below should be taken. Documentary material considered by the Board consisted of Petitioner's application together with all material submitted in support thereof, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies, to include references (b) and (c).

Petitioner reported for duty on board the

- d. Following Petitioner's admission to NCIS that he engaged in homosexual acts while on active duty, on 28 June 2001 Petitioner's command notified him of administrative separation proceedings by reason of homosexual conduct. The Petitioner waived his rights to consult with counsel, submit a statement to the separation authority, and to present his case to an administrative separation board. Ultimately, on 23 August 2001, Petitioner was separated from the Navy for homosexual conduct with an under Other Than Honorable (OTH) conditions characterization of service.
- e. References (b) and (c) set forth the Department of the Navy's current policies, standards, and procedures for correction of military records following the "don't ask, don't tell" (DADT) repeal of 10 U.S.C. 654. It provides service Discharge Review Boards with the guidance to normally grant requests to change the characterization of service to "Honorable" or "General (Under Honorable Conditions)," narrative reason for discharge to "Secretarial Authority," separation code to "JFF," and reentry code to "RE-1J" when the original discharge was based solely on DADT or a similar policy in place prior to enactment of it and there are no aggravating factors in the record, such as misconduct.

## **CONCLUSION:**

Upon review and consideration of all the evidence of record, and in light of references (b) and (c), the Board concludes that Petitioner's request warrants relief. The Board noted Petitioner's record supports that he was administratively discharged solely due to his homosexuality based on DADT, and that there were no aggravating factors in his service record.

Accordingly, the Board concluded that certain remedial changes were warranted to the Petitioner's characterization of service, narrative reason for separation, separation authority, separation code, and reentry code to conform with all current military directives and policy.

## **RECOMMENDATION:**

In view of the foregoing, the Board finds the existence of an injustice warranting the following corrective action.

That Petitioner's character of service be changed to "Honorable," the narrative reason for separation should be changed to "Secretarial Authority," the separation authority be changed to "MILPERSMAN 1910-164," the separation code be changed to "JFF," and the reentry code be changed to "RE-1J."

Petitioner shall be issued a new DD Form 214, Certificate of Release or Discharge from Active Duty.

That any and all previously existing DD Form 214, and DD Form 215, as applicable, be removed from Petitioner's naval record.

That a copy of this report of proceedings be filed in Petitioner's naval record.

- 5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulation, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of reference (a), has been approved by the Board on behalf of the Secretary of the Navy.
