1. Pursuant to the provisions of the reference, Section 1552, Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board) requesting correction of her record to reflect her date of advancement to Chief Petty Officer/E-7 as 16 April 2022. Additionally, she requested a pay audit to ensure she received pay and allowances at the E-7 rate from 16 April 2022 to 2 June 2022 and correction to her Certificate of Release or Discharge from Active Duty (DD Form 214).

2. The Board, consisting of █, █, and █, reviewed Petitioner's allegations of error and injustice on 26 January 2023, and pursuant to its regulations, determined the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval records, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulation within the Department of the Navy.

b. Petitioner was selected for advancement to E-7 by the Fiscal Year 2022 (FY22) Active Duty Navy Chief Petty Officer Advancement Selection Board with numerical order of advancement assignment of 66. On 19 November 2021, she was authorized to assume the title and wear the uniform of a chief petty officer but not entitled to the pay and allowances of the paygrade. The Naval Education and Training Professional Development Center assigned Petitioner an advancement date of 16 April 2022. See enclosures (2) and (3).

c. Petitioner was notified of her selection to the Officer Candidate School (OCS) program on 17 December 2021. She reported to OCS on [REDACTED]. Petitioner was discharged on 2 June 2022 in the rate/paygrade of OCU1/E-6 to accept commission in the naval service. She signed her appointment letter to the grade of Ensign on 3 June 2022. See enclosures (4) through (6).

d. Petitioner contends that while in OCS her advancement to E-7 did not take effect. After unsuccessfully seeking assistance in updating her enlisted record, [REDACTED] directed her to the Board. See enclosures (1) and (7).

e. The Advisory Opinion (AO) at enclosure (8) recommended approval of Petitioner's request for advancement to E-7 effective 16 April 2022, correction of pay and allowances, and correction of enclosure (5) to reflect block 4a as "OCUC" vice "ITC" as requested by Petitioner. Additionally, change block 4b to "E-7" to correctly reflect her rate on 2 June 2022, the date of her discharge from active duty in order to accept a commission in the Navy.

## CONCLUSION

Upon review and consideration of all the evidence of record, the Board finds the existence of an error and injustice warranting partial relief. The Board concurred with the AO and concluded Petitioner's record should reflect she advanced to E-7 effective 16 April 2022.

## RECOMMENDATION

In view of the above, the Board recommends the following corrective action.

Petitioner's naval record be corrected to reflect she was advanced to rate/paygrade ITC/E-7 effective 16 April 2022.

Petitioner's naval record be corrected by modifying blocks 4a and 4b of enclosure (5) to reflect "OCUC" and E-7, respectively.

That DFAS conduct an audit of Petitioner's payment record to determine the pay entitlements that are due as a result of Petitioner's advancement to E-7 effective 16 April 2022.

That no further relief be granted.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.
