- 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to reflect declined participation in the Survivor Benefit Plan (SBP).
- 2. The Board, consisting of reviewed Petitioner's allegations of error and injustice on 2 November 2022 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, he exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings:
- a. In accordance with reference (b), SBP elections must be made prior to retired pay becoming payable and the election to participate in or decline SBP is irrevocable. If not all requirements for an election needing the spouse's concurrence have been satisfied prior to retirement, for whatever reason, full spouse costs, and coverage will be implemented, regardless of any request to do otherwise. Any change in SBP election subsequent to retirement will be done through an administrative correction of records as permitted by law.
  - b. Petitioner married on 14 April 2012.
  - c. Petitioner began active duty on 28 April 2014.
- d. On 18 June 2018, Petitioner signed DD Form 2656, Data for Payment of Retired Personnel electing not to participate in SBP coverage with spousal concurrence; however, Defense Finance and Accounting Service (DFAS) received form without member's witness signature.
- e. On 27 June 2018, Petitioner signed NAVMC 118(11), Administrative Remarks acknowledging receipt of SBP counseling and elected no coverage under SBP.

- f. Petitioner transferred to the Temporary Disability Retired List (TDRL) effective 31 July 2018.
- g. On 15 January 2020, DFAS received an incomplete and unsigned DD Form 2656, Data for Payment of Retired Personnel in case of Petitioner and as a result was automatically enrolled in SBP Spouse coverage effective 31 July 2018.
- h. On 24 October 2022, Petitioner and spouse signed SBP Affidavit before a notary witness requesting to decline SBP coverage.

## CONCLUSION

Upon review and consideration of all the evidence of record, the Board finds the existence of an injustice warranting the following corrective action. The Board concluded Petitioner provided sufficient evidence to reflect his desire to decline SBP coverage prior to transferring to the TDRL. Although Petitioner did not complete the proper administrative requirements, the Board felt that under these circumstances, relief is warranted.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner elected to decline participation in SBP with spouse concurrence prior to transferring to the TDRL effective 31 July 2018.

Note: DFAS will complete an audit of Petitioner's pay records to determine the amount of premium refund.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.
