1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to show Petitioner's Certificate of Release or Discharge from Active Duty (DD Form 214) executed on 27 June 2022 show block 12.a. (Date entered AD this period) as "28 June 2017" vice "28 June 2022."

2. The Board, consisting of [REDACTED], [REDACTED], and [REDACTED] reviewed Petitioner's allegations of error and injustice on 3 November 2022 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies, to include reference (b).¹

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. On 8 March 2017, Petitioner enlisted in the U.S. Naval Reserve for 8 years with an Expiration of Obligated Service of 7 March 2025.

¹ Reference (b), the DD Form 214 is prepared to cover periods of service on active duty, active duty for training, full-time support, active duty for special work, certain periods terminated by a change of status not concurrent with separation from active service, and release from a status that is legally determined to be void. The DD form 214 will be issued to members in conjunction with their release from active duty and prior to departure from their command or separation activity on permissive temporary duty, terminal leave, and associated travel.

Block 12a (Date entered AD this period). The date entered in block 12 a will be the date of enlistment for the earliest period of continuous active service for which a DD 214 was not previously issued. For members who have previously enlisted, reenlisted, or accepted an appointment without being issued a DD For 214 and who are being separated with any discharge characterization except "Honorable," the following statement must appear as the first entry in lock 18 on the DD 214: "CONTINUOUS HONORABLE ACTIVE SERVICE FROM (applicable date) UNTIL applicable date)." The "from" date will be the date of initial entry into active duty; the "until" date will be the date before commencement of the current enlistment.

c. On 28 June 2017, Petitioner entered active duty for 4 years with an End of Active Obligated Service of 27 June 2021 and Soft End of Active Obligated Service of 27 June 2022.

d. On 2 May 2022, Petitioner was issued official separation orders (BUPERS order: [REDACTED]) while stationed in [REDACTED] with an effective date of departure of May 2022. Petitioner's place elected for travel was [REDACTED] with an effective date of 27 June 2022 and an honorable character of service.

e. Petitioner was issued a DD Form 214 after completion of required active service, and block 12.a. listed "28 June 2022" vice "28 June 2017."

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that Petitioner entered active duty on 28 June 2017, however, Petitioner's DD Form 214 executed on 27 June 2022 lists 28 June 2022 in block 12.a.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner will be issued a DD Form 215 to correct his DD Form 214 executed on 27 June 2022 by changing block 12.a. (Date entered AD this period) as "28 June 2017" vice "28 June 2022." Note: That any other entries affected by the Board's recommendation be corrected.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
