
Dear ,

This is in reference to your application for correction of your naval record pursuant to Section 1552 of Title 10, United States Code. After careful and conscientious consideration of relevant portions of your naval record and your application, the Board for Correction of Naval Records (Board) found the evidence submitted insufficient to establish the existence of probable material error or injustice. Consequently, your application has been denied.

A three-member panel of the Board, sitting in executive session, considered your application on 9 November 2022. The names and votes of the members of the panel will be furnished upon request. Your allegations of error and injustice were reviewed in accordance with administrative regulations and procedures applicable to the proceedings of this Board. Documentary material considered by the Board consisted of your application, together with all material submitted in support thereof, relevant portions of your naval record and applicable statutes, regulations, and policies.

You requested to change your Sergeant (Sgt)/E-5 date of rank (DOR) from 1 June 2019 to 26 July 2019 in accordance with your Active Reserve (AR) Program Date of Rank Adjustment Statement of Understanding. The Board, in its review of your entire record and application, carefully weighed all potentially mitigating factors, to include your assertions. A review of your record indicates that on 13 January 2020, you submitted your Reenlistment/Lateral Move (RELM) request for a first term AR Accession with extension. The Commandant of the Marine Corps Reserve Affairs approved your RELM on 7 April 2020 to be accessed in the AR Program on 15 August 2020 as a Sgt/E-5 with a DOR of 1 June 2019 in the 0111 Military Occupational Specialty (MOS). You submitted your Memorandum Endorsement on this same date acknowledging the aforementioned. On 17 April 2020, you signed a NAVMC 321A, Agreement to Extend Enlistment, to extend your reserve obligation for 16 months past your original reserve obligation end date to 2 October 2024. You were released from the active component on 18 June 2020 and transferred to the Individual Ready Reserve. As approved, you were accessed to the AR Program on 15 August 2020, 58 days after your release from the active component.

In accordance with Marine Corps Order 1001.52K, the appropriate DOR is determined based on the method prescribed in the current Marine Administrative Message (MARADMIN) regarding



AR Enlisted Career Force Controls. As promulgated in MARADMIN 519/19, Fiscal Year 2020 AR Program Enlisted Career Force Controls Program, active component Sgt/E-5 who are MOS matches and join within 90 days of being released from active duty (component code 11) will retain their original date of rank. Therefore, the Board found no error with your 1 June 2019 DOR approval.

You are entitled to have the Board reconsider its decision upon submission of new matters, which will require you to complete and submit a new DD Form 149. New matters are those not previously presented to or considered by the Board. In this regard, it is important to keep in mind that a presumption of regularity attaches to all official records. Consequently, when applying for a correction of an official naval record, the burden is on the applicant to demonstrate the existence of probable material error or injustice.
