| 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to establish enrollment into the Blended Retirement System (BRS). | |
| 2. The Board, consisting of, and reviewed Petitioner's allegations of error and injustice on 30 November 2022 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies. | |
| 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, he exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings: | |

e. Petitioner's last day to elect to opt-into BRS was 27 July 2021.

- f. Petitioner completed BRS Opt-in Training (J3OP-US1332) on 19 August 2022.
- g. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action. On 29 November 2022, Petitioner concurred with OPNAV (N130) assessment.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. Petitioner met the eligibility criteria for BRS; however, failed to complete the election process as outlined in reference (b). Although Petitioner did not complete the proper administrative requirements, the Board felt that had he received adequate counseling, he would have made the BRS election in a timely manner; therefore, under these circumstances, relief is warranted.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner is authorized to opt into BRS within 30 days of receiving this decision document.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.
