- 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that her naval record be corrected to reflect entering active duty on 17 September 2013 in block 12a of the Certificate of Release or Discharge from Active Duty (DD Form 214) ending on 16 September 2017.
- 2. The Board, consisting of previous problem, and previous problems, allegations of error and injustice on 29 November 2022 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, she exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings:
- a. On 20 February 2013 Petitioner enlisted in the Naval Reserve for a term of 8 years of which 4 years was an active duty obligation. Petitioner entered active duty on 17 September 2013, and on 16 September 2017, Petitioner was released from active duty and transferred to the Navy Reserve. The DD Form 214 issued indicating Petitioner entered active duty on 17 September 2103.

CONCLUSION

Upon review and consideration of all the evidence of record, the Board finds the existence of an injustice warranting the following corrective action. The Board concluded Petitioner's DD Form 214 contained a typographical error in block 12a, therefore, under this circumstance, relief is warranted.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner will be issued a DD Form 215 Correction to the DD Form 214, with Block 12a (Date Entered AD this Period) "20130917" vice "21030917."

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

- 4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.
- 5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
