1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to show Petitioner was reimbursed for his Personally Procured Move (PPM).

2. The Board, consisting of [REDACTED], [REDACTED], and [REDACTED] reviewed Petitioner's allegations of error and injustice on 15 December 2022 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. On 31 August 2022, 14 September 2022, and 18 October 2022 Petitioner's wife received payment receipts from SecurCare Self Storage Lease for \$207.00, \$181.00, and \$181.00.

b. On 1 September 2022 U-Haul issued Petitioner an Equipment Contract receipt for \$528.44, and at 09:46 Certified Automated Truck Scale receipt was issued at [REDACTED] with gross weight of 9,840 lbs., and at 22:02 Certified Automated Truck Scale receipt was issued at [REDACTED], [REDACTED] with gross weight of 17,680 lbs.

c. On 10 November 2022 Petitioner was issued official separation orders (BUPERS order: [REDACTED]) while stationed in [REDACTED], [REDACTED] with an effective date of departure of November 2022. Petitioner's place elected for travel was [REDACTED], [REDACTED] with an effective date of 10 November 2022.

d. Petitioner was released from active duty and transferred to the Navy Reserve with an honorable character of service and was issued a Certificate of Release or Discharge from Active Duty (DD Form 214) for the period of 7 April 2015 to 10 November 2022 upon completion of required active service.

e. On 16 November 2022 NAVSUP Fleet Logistics Center Norfolk notified Petitioner that Petitioner moved prior to the issuance date and their office cannot process his move. Petitioner was advised that he could try to contact the Board for Correction of Naval Records.

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of reference (b)<sup>1</sup> and enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded per reference (b) household goods (HHG) allowances are based on the when orders are effective and certain criteria must be met in order to execute HHG transportation before an order is issued. Petitioner was preparing to separate from active duty, therefore, he had reason to believe that separation orders would be forthcoming.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's official separation orders (BUPERS order: [REDACTED]) were issued on "30 August 2022" vice "10 November 2022."

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.

<sup>1</sup> Reference (b), HHG allowances are based on the permanent change of station (PCS) order's effective date; although, the HHG may be transported as long as the HHG authority remains in effect. The weight allowance is based on the grade held on the effective date of the order authorizing the HHG transportation. HHG transportation before a PCS order is issued is authorized if the request for transportation is supported by all of the following: a. A statement from the authorizing/Order-Issuing Official (AO) or designated representative that the Service member was advised before such an order was issued that it would be issued. b. A written agreement, signed by the applicant, to pay any additional costs incurred for transportation to another point required because the new permanent duty station named in the order is different than that named in the AO's statement. c. A written agreement, signed by the applicant, to pay the entire transportation cost if a PCS order is not later issued to authorize the transportation.
