1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that her naval record be corrected to reflect date entered active duty service as 26 November 1982 on her Certificate of Discharge or Release from Active (DD Form 214) ending on 30 November 2007.

2. The Board, consisting of [REDACTED], [REDACTED], and [REDACTED] reviewed Petitioner's allegations of error and injustice on 4 January 2023 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, he exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings:

a. On 26 November 1982 Petitioner entered active duty Navy, and was discharged for immediate reenlistment on 24 October 1989 and was issued DD Form 214 for active duty service period of 26 November 1982 through 24 October 1989. Petitioner reenlisted on 25 October 1989 for a term of 6 years and thereafter, executed extensions for an aggregate of 41 months.

b. Petitioner reenlisted again on 25 March 1999 for a term of 3 years and thereafter, executed extensions for an aggregate of 48 months, and reenlisted again on 6 March 2006 for a term of 2 years.

c. On 30 November 2007 Petitioner transferred to the Fleet Reserve and was issued a DD Form 214 for active duty service period of 26 October 1989 through 30 November 2007, and transferred to the Retired List effective 1 December 2012.

CONCLUSION

Upon review and consideration of all the evidence of record, the Board finds the existence of an injustice warranting the following corrective action. The Board concluded Petitioner was issued DD Form 214 for service from 26 November 1982 through 24 October 1989.¹ However, the DD Form 214 ending on 30 November 2007 contained an error with the entry date for this period, therefore, partial relief is warranted.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner will be issued a DD Form 215, correction to her DD Form 214 ending on 30 November 2007 to correct Block 12a (Date Entered AD this Period) as 89 Oct 25 vice 89 Oct 26.

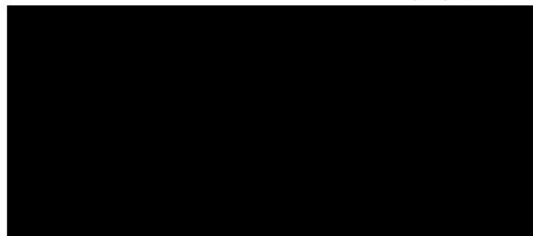

¹ Reference (b), the DD Form 214 will be prepared and furnished to members while serving on active duty when they have a change of status or component such as enlisted personnel discharged for the purpose of immediate enlistment or reenlistment. Reference (c), ended the authorization to issue a DD Form 214 to members discharged for the purpose of immediate reenlistment in the Navy on 28 June 1993.
