1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to show Petitioner was eligible for and received a Selective Reenlistment Bonus (SRB).

2. The Board, consisting of [REDACTED], [REDACTED], and [REDACTED] reviewed Petitioner's allegations of error and injustice on 5 January 2023 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. On 16 July 2013, Petitioner entered active duty.

c. On 4 October 2019, Petitioner reenlisted for 4 years with an End of Active Obligated Service (EAOS) of 3 October 2023.

d. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component (AC) and Full-Time Support (FTS), superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365-days of their EAOS (as opposed to 270-days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

e. On 29 August 2022, Petitioner was issued official change duty orders (BUPERS order: [REDACTED]) with required obligated service to May 2026, while stationed in [REDACTED], [REDACTED] with an effective date of departure of February 2023. Petitioner's intermediate activity was [REDACTED], [REDACTED], [REDACTED] for temporary duty under instruction with an effective date of arrival of 4 February 2023. Petitioner's ultimate activity was [REDACTED], [REDACTED] for duty with an effective date of arrival of 4 May 2023, with a Projected Rotation Date (PRD) of May 2026.

f. In accordance with reference (c), FY23 SRB Award Plan (N13 SRB 001/FY23) a zone "B" SRB with an award level of 2.0 (\$45,000 award ceiling) for the ITS rate was listed.

g. On 7 November 2022, Petitioner signed a command career request (NPPSC 1160/1) requesting a 6 year reenlistment effective 30 November 2022. Petitioner's request was approved on 23 November 2022 by cognizant authority.

h. On 30 November 2022, Petitioner reenlisted for 6 years with an EAOS of 29 November 2028.

i. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that Petitioner signed a command career request (NPPSC 1160/1) requesting a 6 year reenlistment effective 30 November 2022. Petitioner reenlisted on 30 November 2022 for 6 years, and at the time of reenlistment, Petitioner was eligible for a zone B SRB. If the Command Career Counselor had submitted the SRB precertification to BUPERS 328 in advance of member's requested reenlistment date, he would have been approved for Zone B, 2.0 award level SRB.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's Command submitted a waiver request for his SRB to BUPERS-328 via OPINS/NSIPS less than 35 days in advance of the requested reenlistment date of the Sailor and was approved by cognizant authority.

Note: This change will entitle the member to a zone "B" SRB with an award level of 2.0 (\$45,000 award ceiling) for the ITS rate. Remaining obligated service to 3 October 2023 will be deducted from SRB computation

A copy of this Report of Proceedings will be filed in Petitioner's naval record.
