1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to show Petitioner was eligible for and received a Selective Retention Bonus (SRB) and Early Reenlistment Kicker.

2. The Board, consisting of [REDACTED], [REDACTED], and [REDACTED] reviewed Petitioner's allegations of error and injustice on 2 February 2023 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. On 14 November 2016 Petitioner entered active duty, and was assigned Primary Military Occupational Specialties (PMOS) 0311 on 16 May 2017.

b. On 5 May 2021 Petitioner reenlisted for 2 years with an end of current contract (ECC) of 4 May 2023, and was promoted to Sergeant/E-5 on 1 June 2021.

c. On 26 January 2022 Petitioner signed an agreement to extend enlistment for 29 months with an end of active service of 4 October 2025 in order to obligate service for assignment.

d. On 15 June 2022 reference (b), announced the SRB program and the Broken Service SRB program authorized for FY23. With the advent of several new SRB programs, Marines are

encouraged to thoroughly review the contents of this bulletin. First term Marines (Zone A) and career Marines (Zone B, C, D, E, F, and G) who reenlist on or after 14 June 2022 are eligible for the FY23 SRB program. This will include any regular component first term or career Marine with an ECC from 1 October 2022 to 30 September 2023.

FY23 Cohort In-Year Early Reenlistment Kicker. Marines in Zone A who submit for a minimum of 48 month reenlistment before 30 September 2022 with a PMOS that is listed in paragraph 3.m, are subsequently approved, will rate an 8,000 dollar Early Reenlistment Kicker in addition to the PMOS bonus amount listed in paragraph(s) 3.m, 3.n, and 3.o. After 30 September 2022, this Early Reenlistment Kicker will expire.

Zone A applies to those active component Marines with 17 months to 6 years of active military service. Zone A PMOS bonus payments for Marines who reenlist for at least 48 months obligated service are authorized as listed below in dollars (bonuses for Marines who reenlist for 36 to 47 months obligated service will be calculated as per para 3.j). Furthermore, a Zone "A" SRB for MOS 0311, E-5, which is capped at \$18,000 for 48 months of additional obligated service was authorized.

e. On 15 September 2022 Petitioner was assigned ADMOS1 8152, and on 30 September 2022 Petitioner's Careerist Active Duty Reenlistment request was submitted and approved by Headquarters, U.S. Marine Corps (HQMC) on 3 November 2022 with a No Later Than date of 17 November 2022.

f. On 14 November 2022 Petitioner entered Zone B, and reenlisted on 15 November 2022 for 4 years and 6 months with an ECC of 14 May 2027.

g. In the advisory opinion, attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 30 September 2022, Petitioner submitted a 48-month reenlistment with SRB request to HQMC. On 3 November 2022, HQMC approved a 48-month reenlistment with a Zone A SRB and Early Reenlistment Kicker with a reenlistment authority expiration date of 17 November 2022. On 14 November 2022, Petitioner entered Zone "B" and became ineligible for a Zone A SRB and Early Reenlistment Kicker. HQMC erred by approving a reenlistment with a Zone A SRB with an expiration date after Petitioner's SRB Zone changed.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner was discharged and reenlisted on 10/11 October 2022, vice on 14/15 November 2022 for a term of 4 years and 7 months vice 4 years and 6 months.

Note: This change will entitle the member to a Zone "A" SRB for MOS 0311, E-5, which is capped at \$18,000 for 48 months of additional obligated service. Remaining obligated service to 4 May 2023 will be deducted from SRB computation. Furthermore, Petitioner was entitled to \$8,000 Early Reenlistment Kicker.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
