1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to show Petitioner's Certificate of Release or Discharge from Active Duty (DD Form 214), executed on 24 May 2018, listed 5 months and 6 days vice 5 years in block 12c (Net Active Service This Period).

## 2. The Board, consisting of

to its regulations, determined

that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. On 27 September 2017 Petitioner enlisted in the Marine Corps Reserve for 8 years with an expiration of obligated service of 26 September 2025.

b. Petitioner served on a period of active duty from 18 December 2017 to 24 May 2018, and was separated with entry level performance and conduct discharged—Block 12c listed 5 years.

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following partial corrective action. The Board concluded that Petitioner served on active duty from 18

December 2017 through 24 May 2018 in the United States Marine Corps. This totals 5 months and 7 days, not the 5 months and 6 days Petitioner requested.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's DD Form 214, executed on 24 May 2018 listed block 12c (Net active service this period) 5 months and 7 days vice 5 years. Note: Petitioner will be issued a DD Form 215 to correct the error on his DD Form 214.

That part of the Petitioner's request for corrective action that exceeds the foregoing be denied.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
