1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that her naval record be corrected to reflect date entered active duty service as 24 June 1981 on DD Form 214, Certificate of Discharge or Release from Active ending on 30 November 1993.

2. The Board, consisting of [REDACTED], and [REDACTED] reviewed Petitioner's allegations of error and injustice on 20 April 2023 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, she exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings:

a. On 8 March 1981, Petitioner enlisted in Naval Reserve for a term of 6 years of which 4 years was an active duty obligation; Petitioner was in the Delayed Entry Program through 23 June 1981, and entered active duty on 24 June 1981.

b. On 24 May 1985, Petitioner reenlisted for a term of 6 years. Petitioner's official military personnel file (OMPF) does not reflect that a DD Form 214 was issued for active duty period of 24 June 1981 through 23 May 1985.

c. On 30 November 1993, Petitioner discharged and issued DD Form 214 for active duty period of 24 May 1985 through 30 November 1993. However, Block 12d (Total Prior Active Service) correctly reflects 3 years, 11 months, and 00 days.

## CONCLUSION

Upon review and consideration of all the evidence of record, the Board finds the existence of an injustice warranting the following corrective action. The Board concluded Petitioner was entitled to a DD Form 214 to capture active duty service from 24 June 1981 through 23 May 1985 in accordance with reference (b).<sup>1</sup> However, there is no evidence in Petitioner's OMPF reflecting issuance of a DD Form 214 for the aforementioned period. Therefore, the Board agreed, under this circumstance, partial relief warranted.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner issued DD Form 214, Certificate of Release or Discharge from Active Duty for the period of 24 June 1981 to 23 May 1985.

The part of Petitioner's request for corrective action that exceeds the foregoing is denied in accordance with reference (b). Active duty service period captured on DD Form 214 dated 30 November 1993 is correct.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.
5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
