1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to reflect date entered active duty service as 8 July 2008 on his DD Form 214, Certificate of Discharge or Release from Active dated 25 January 2021.

2. The Board, consisting of [REDACTED], [REDACTED], and [REDACTED] reviewed Petitioner's allegations of error and injustice on 6 April 2023 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, he exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings:

- a. On 15 December 1990, Petitioner enlisted in the Naval Reserve for a term of 8 years.
- b. Petitioner served on active duty from 18 March 1991 through 17 March 1993; DD Form 214 issued for this period of service indicating released from active duty with a Reserve Obligation Termination date of 14 December 1998.
- c. Petitioner was assigned to the Individual Ready Reserve (IRR) from 18 March 1993 to 25 March 1993, and affiliated with the Selected Reserve on 26 March 1993.
- d. Petitioner executed Active Duty for Training orders from 11 April 1994 to 22 April 1994, and transferred back to the IRR on 23 August 1996.
- e. On 14 December 1998, Petitioner discharged from the Naval Reserve and issued NAVPERS 1070/615, Record of Discharge from the US Navy Reserves.
- f. On 1 February 2007, Petitioner enlisted in the Naval Reserve for a term of 6 years; Pay Entry Base Date adjusted to 4 May 1999 to account for time off contract.

g. On 8 July 2008, Petitioner reenlisted for a term of 4 years under the Full Time Support (FTS) program; Active Duty Service Date (ADSD) adjusted to 13 June 2006 based on previous active duty service.

h. On 26 February 2021, Petitioner transferred to Permanent Disability Retired List. Petitioner issued DD Form 214 indicating, Block 12a (Date Entered AD This Period) 2006 06 13; Block 12b (Separation Date Entered This Period) 2021 02 26; Block 12c (Net Active Services This Period) 14 years, 08 months, and 14 days; and Block 12d (Total Prior Active Service) 02 years, 00 months, and 00 days.

#### CONCLUSION

Upon review and consideration of all the evidence of record, the Board finds the existence of an injustice warranting the following corrective action. The Board concluded Petitioner's official military personnel file indicates Petitioner had over an 8 year break in service before enlisting in the Navy Reserve on 1 February 2007. Petitioner returned to active duty under the FTS program on 8 July 2008, which adjusted his ADSD to 13 June 2006 because of previous active duty service. Consequently, the Board determined the DD Form 214 dated 25 January 2021 contains errors and therefore, under these circumstances, relief is warranted.

#### RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's DD Form 214 dated 25 January 2021 is amended to reflect Block 12a (Date Entered AD this Period) "2008 07 08" vice "2006 06 13." Note: The Service is authorized to modify blocks 12b through 12h as required by the aforementioned change.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
