1. Pursuant to the provisions of reference (a) Section 1552, Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board) requesting correction of her record, specifically her January 2019 (Cycle 242) advancement worksheet.
2. The Board, consisting of reviewed Petitioner's allegations of error and injustice on 18 May 2023, and pursuant to its regulations, determined the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval records, and applicable statutes, regulations, and policies.
3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found as follows:
a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulation within the Department of the Navy.
b. Petitioner participated in the January 2019 (Cycle 242) Navy-Wide Advancement Exam (NWAE) but did not meet the minimum Final Multiple Score (FMS) required to become selection board eligible for chief petty officer. Her calculated FMS, 157.66, did not meet the minimum required score of 159.91 .
c. Petitioner contends that her Performance Mark Average (PMA) was miscalculated because the value for the Reporting Senior Cumulative Average for the periodic evaluation for the reporting period 30 March 2018 to 15 November 2018 was " 0.0 ," an error that was beyond her control.
d. The Advisory Opinion (AO) at enclosure (2) recommended approval of Petitioner's request to recalculate her FMS because her PMA was previously miscalculated. The AO states the corrected PMA of $112.50(3.85)$ raises the FMS to 160.16 which exceeds the minimum

required FMS of 159.91. With the corrected FMS, Petitioner would be selection board eligible for the January 2019 (Cycle 242) NWAE.

## CONCLUSION

Upon review and consideration of all the evidence of record, the Board finds the existence of an error and injustice warranting relief. The Board concurred with the AO and concluded Petitioner's PMA and FMS should be recalculated for the January 2019 (Cycle 242) NWAE.

## RECOMMENDATION

In view of the above, the Board recommends the following corrective action.
Petitioner's naval record be corrected by recalculating Petitioner's PMA and FMS for the January 2019 (Cycle 242) NWAE.
