- 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected by issuing two DD Form 214, Certificate of Release or Discharge from Active Duty. The active duty periods are 12 June 1981 to 11 June 1985 and 23 September 1986 to 31 January 1993.
- 2. The Board, consisting of ______, and _____ reviewed Petitioner's allegations of error and injustice on 25 May 2023 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, he exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings:
- a. In accordance with reference (b), the DD Form 214 will be prepared and furnished to members while serving on active duty when they have a change of status or component such as enlisted personnel discharged for the purpose of immediate enlistment or reenlistment.
- b. On 11 June 1985, Petitioner released from active duty and transferred to the Naval Reserve to complete military service obligation. DD Form 214 issued for active duty period of 12 June 1981 to 11 June 1985.
 - c. On 25 October 1985, Petitioner discharged from the Naval Reserve.

- d. On 15 September 1986, Petitioner enlisted in Naval Reserve for a term of 8-years under the Delayed Entry Program. Petitioner entered active duty this period on 23 September 1986.
- e. On 30 September 1987, Petitioner signed an extension agreement that indicates "Having enlisted in the U.S. Navy on 86SEP23 for 2 years, I voluntarily agree to (further) extend my enlistment for 2 months subject to the provisions and obligations of my enlistment contract."
- f. On 23 November 1988, an agreement to extend Petitioner's enlistment for 21-months was made operative.
- g. On 16 October 1989, Petitioner advanced to Aviation Electrician's Mate First Class (AE1)/E-6.
- h. On 17 August 1990, Petitioner reenlisted for a term of 4-years. DD Form 214 is not filed in official military personnel file (OMPF) for the active duty period of 23 September 1986 to 16 August 1990.
- i. On 31 January 1993, Petitioner discharged and issued DD Form 214 for active duty period of 17 August 1990 to 31 January 1993 with previous service captured in Block 12d as 7-years, 10-months, and 24-days.

CONCLUSION

Upon review and consideration of all the evidence of record, the Board finds the existence of an injustice warranting the following corrective action. The Board concluded Petitioner's OMPF contains copies of DD Form 214 for active duty periods of 12 June 1981 to 11 June 1985 and 17 August 1990 to 31 January 1993. However, there is no evidence Petitioner was issued a DD Form 214 for active duty service of 23 September 1986 to 16 August 1990 in accordance with reference (b); therefore, the Board agreed, under these circumstances, partial relief is warranted.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner issued DD Form 214, Certificate of Release or Discharge from Active Duty for the period of 23 September 1986 to 16 August 1990.

The part of Petitioner's request for corrective action that exceeds the foregoing is denied. Previous active duty service periods are captured on DD Form 214s in Petitioner's OMPF. Petitioner can request replacement copies of DD Form 214s by submitting a request online at https://www.archives.gov/veterans/military-service-records or submitting an SF-180, Request Pertaining to Military Record to National Personnel Records Center.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

- 4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.
- 5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
