1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, a former enlisted member of the Navy, filed enclosure (1) with this Board requesting, in effect, that his record be changed per reference (c). Enclosures (1) through (3) apply.

2. The Board, consisting of █, █, and █, reviewed Petitioner's allegations of error and injustice on 15 May 2023 and, pursuant to its regulations, determined that the corrective action indicated below should be taken. Documentary material considered by the Board consisted of Petitioner's application together with all material submitted in support thereof, relevant portions of Petitioner's naval record, applicable statutes, regulations, and policies to include the references.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. Although enclosure (1) was not filed in a timely manner, it is in the interest of justice to waive the statute of limitations and review the application on its merits.

c. Petitioner enlisted in the Navy and entered active duty on 2 July 2003. On 6 March 2004, Petitioner made a written statement admitting to engaging in homosexual acts. Subsequently, Petitioner was notified of pending administrative separation action by reason of misconduct due to homosexual admission. After waiving his procedural rights, Petitioner's commanding officer (CO) forwarded his package to the separation authority (SA), recommending his discharge by reason of homosexual admission with a General (Under Honorable Conditions) (GEN) characterization of service.

On 18 June 2004, Petitioner recanted his statement of being a homosexual by stating his admission was fabricated due to his desire to be discharged. On 29 June 2004, Petitioner recanted his statement made on 18 June 2004 by admitting he is actually homosexual and participated in homosexual acts during military service. On 2 July 2004, the SA agreed with the CO's recommendation for discharge but directed an Honorable characterization of service. On 6 July 2004, Petitioner received non-judicial punishment (NJP) for failure to obey a lawful order. On 19 July 2004, Petitioner was discharged with an Honorable characterization of service by reason of homosexual admission.

d. Petitioner contends that his discharge was based solely on his sexual preference.

e. Reference (c) sets forth the Department of the Navy's current policies, standards, and procedures for correction of military records following the "don't ask, don't tell" (DADT) repeal of 10 U.S.C. 654. It provides service Discharge Review Boards with the guidance to grant requests to change the narrative reason for separation to "Secretarial Authority," SPD code to "JFF," and reentry code to "RE-1J," when the original discharge was based solely on DADT or a similar policy in place prior to enactment of it and there are no aggravating factors in the record, such as misconduct.

#### CONCLUSION:

Upon review and consideration of all the evidence of record, and especially in light of references (b) and (c), the Board concludes that Petitioner's request warrants relief. In this regard, the Board noted that Petitioner was separated based solely on his homosexual admission. Therefore, while the Board noted the minor misconduct in Petitioner's record, they concluded he was entitled to full relief under reference (c).

In view of the foregoing, the Board directs the following partial corrective action.

#### RECOMMENDATION:

That Petitioner's record be corrected to show that, on 19 July 2004, his narrative reason for separation was "Secretarial Authority," reenlistment code was "RE-1J," SPD code was "JFF," and his separation authority was "MILPERSMAN 1910-164."

That Petitioner be issued a new DD Form 214.

That no further changes be made to the record.

That a copy of this report of proceedings be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulation, Section 723.6(e)) and having assured compliance with its provisions, it is hereby announced that the foregoing
