1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to remove an Administrative Remarks (Page 13) counseling entry from her official military personnel file (OMPF).

2. The Board, consisting of [REDACTED], [REDACTED], and [REDACTED], reviewed Petitioner's allegations of error and injustice on 30 May 2023, and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of the naval records, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. On 24 April 2017, Petitioner ran a Physical Readiness Test (PRT) where her overall performance resulted in a "good high." Specifically, Petitioner scored 65 points for executing 70 curl ups, 65 points for executing 31 push-ups, and 80 points for completing the bike in 12:25. Enclosure (2).

c. On 27 April 2017, Petitioner received a NAVPERS 1070/613 counseling entry for failure to meet PRT standards. Specifically, the Page 13 incorrectly identified the Petitioner as scoring 31 points vice 65 points for the push up portion of the PRT. Enclosure (3).

d. Petitioner contends that the Page 13 was issued in error and that she was never informed of the counseling entry nor did she sign the Page 13.

e. The Advisory Opinion (AO), furnished by the Physical Readiness Section (OPNAV N171A), noted that the contested counseling entry was on file. The AO further noted that there a review of her Physical Fitness Assessment results located with the Physical Readiness Information Management System reflected that the Petitioner passed her Body Composition Assessment as well as her PRT and she should not have been issued the Page 13. The AO further noted that there was no signature on the contested counseling entry. Enclosure (4)

#### CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the AO, the Board finds the existence of an error warranting relief. The Board substantially concurred with the AO that the counseling entry was submitted in error and determined that the Petitioner furnished sufficient evidence to conclude that she passed the PRT. The Board thus concluded that the counseling entry is erroneous and shall be removed from Petitioner's OMPF.

#### RECOMMENDATION

In view of the above, the Board directs the following corrective action.

Petitioner's naval record be corrected by removing enclosure (2), her 27 April 2017 NAVPERS 1070/613 counseling entry.

That no further relief be granted.
