1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting removal of the Body Composition Program (BCP) counseling entries from 2022.	
2. The Board, consisting of reviewed Petitioner's allegations of error and injustice on 20 July 2023, and pursuant to its regulations, determined the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval records, and applicable statutes, regulations, and policies.	
3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found as follows:	
a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulation within the Department of the Navy.

	n support of Petitioner's request for removal, Commanding Officer, , Marine Forces Reserve, in his letter at enclosure (6),
stated Petitioner was erroneously assigned to the Marine Corps BCP and requested the	

"assignment period of 14 May 2022 to BCP" be removed due to administrative error and "failure to maintain the NAVMC 11621" in accordance with reference (b).

CONCLUSION

Upon review and consideration of all the evidence, the Board determined Petitioner's request warrants partial relief. Relying on the CO's letter at enclosure (6), the Board determined it was in the interest of justice to remove the Page 11 entries for "the assignment period of 14 May 2022" which reference the BCP assignment. Noting enclosure (6) specified "the assignment period of 14 May 2022," the Board concluded enclosures (4) and (5) should remain in Petitioner's record.

RECOMMENDATION

In view of the above, the Board directs the following corrective action.

Petitioner's naval record be corrected by removing the Page 11 counseling entry dated 14 May 2022 at enclosure (2) and the Page 11 entry dated 14 May 2022 at enclosure (3).

That any material or entries inconsistent with or relating to the Board's recommendation be corrected, removed, or completely expunged from Petitioner's record, and that no such entries or material be added to the record in the future. This includes, but is not limited to, all information systems or database entries that reference or discuss the expunged material.

- 5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulation, Section 723.6(e)) and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of reference (a), has been approved by the Board on behalf of the Secretary of the Navy.
