under e	ore applying to this Board, Petitioner exhausted all administrative remedies available existing law and regulations within the Department of the Navy. The Board, having ed all the facts of record pertaining to Petitioner's allegations of error and injustice finds ows:
a. (	On 19 November 2019, Petitioner transferred from on 23 December 2019 for duty.
b. <b>(</b>	On 25 September 2020, Petitioner was advanced to ETN2/E-5.
Officer verifica	On 3 November 2020, Unaccompanied Housing, Naval Base notified Disbursing r, Personnel Support Detachment, Naval Base that "[t]his form is submitted as ation that the following member does not currently reside in Unaccompanied Housing at Base And "[h]as officially checked out of Unaccompanied Housing."

- d. On 8 June 2023, Petitioner's single BAH request was submitted and approved by cognizant authority on 14 June 2023. On 7 August 2023, Installation Housing Director approved Petitioner's request.
- e. On 9 June 2023, Commanding Officer, notified Director, Transaction Service Center, that "[t]he following member's eligibility for single BAH is based on advancement date to E-5 on 25 September 2020 and [Petitioner] not residing in Unaccompanied Housing as of 3 November 2020." And "[d]ue to administrative error at the time of [Petitioner] becoming eligible for BAH, [Petitioner's] BAH request was not submitted properly. [Petitioner] was unaware of the situation and did not realize he was not receiving correct entitlements in his pay. The error was caught just recently during a command pay audit and [Petitioner] took immediate action to provide necessary documentation to start BAH. His original BAH request chit was unable to be located however. Due to the circumstance, we request [Petitioner's] BAH be started based on his initial eligibility date of 3 November 2020."
- f. On 1 August 2023, Petitioner was authorized BAH at the without dependents rate for Bremerton, WA 98310 effective 12 July 2023.

## **CONCLUSION**

Upon review and consideration of all the evidence of record, and especially in light of the contents of reference (b)¹ and enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. On 25 September 2020, Petitioner was advanced to ETN2/E-5. On 3 November 2020, Unaccompanied Housing confirmed that Petitioner checked out of Unaccompanied Housing. On 8 June 2023, Petitioner's single BAH request was submitted and approved by cognizant authority on 14 June 2023. On 7 August 2023, Installation Housing Director approved Petitioner's request. The Board concluded that there is no evidence of Petitioner requesting BAH prior to 8 June 2023, however based on Petitioner's commanding officer's letter, Petitioner's request was not submitted properly and he was not paid correctly as a result of this administrative error. Petitioner was eligible for BAH at the without dependents rate based on rank and was not residing in Unaccompanied Housing as of 3 November 2020, and received the Installation Housing Director's approval.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner was authorized BAH at the without dependents rate for effective 3 November 2020 to 11 July 2023.

<sup>&</sup>lt;sup>1</sup> Reference (b), Navy policy restricts eligibility to berth ashore for single shipboard Sailors E-5 and E-4 (with greater than four years of service), contingent upon the approval of their commanding officer. This approval, however, does not constitute an authorization to receive a housing allowance, but simply allows the member to reside off the ship. The shore-based facility commander shall make the determination whether the member will be berthed in single bachelor quarters or entitled to draw an off-base housing allowance.

A copy of this report of proceedings will be filed in Petitioner's naval record.
