1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that her naval record be corrected to show Petitioner was reimbursed for her Personally Procured Move (PPM).

2. The Board, consisting of **sector and applicable statutes**, regulations, and policies. reviewed Petitioner's allegations of error and injustice on 2 November 2023 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 17 May 2023, Supercenter, second issued Petitioner a receipt for packing supplies.

b. U-Pack issued Petitioner a contract with a drop off date of 30 May 2023 with a shipment date of 5 June 2023. Total Charges was \$3,062.00.

c. Petitioner was discharged with an honorable character of service and was issued a DD Form 214, Certificate of Release or Discharge from Active Duty for the period of 15 November 2017 to 9 June 2023 due to disability, severance pay, non-combated related IDES.

d. On 13 June 2023, Petitioner was issued official separation orders (BUPERS order: 1643) while stationed in the stationed in

departure of November 2023. Petitioner's place elected for travel: with an effective date of separation of 14 November 2023.

e. On 25 July 2023, Petitioner was issued official modification to separation orders (BUPERS order: 1643) while stationed in the second separation of April 2023. Petitioner's place elected for travel: the with an effective date of separation of 26 July 2023.

f. On 1 November 2023, NAVSUP Fleet Logistics Center **Example** notified the Board that Petitioner's move date was 2 June 2023 and her claim was denied 23 August 2023.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of reference (b) and enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded per reference (b), household goods allowances are based on the when orders are effective and certain criteria must be met in order to execute household goods transportation before an order is issued. Petitioner was preparing for her medical discharge; therefore, she had reason to believe that official separation orders would be forthcoming. Furthermore, Petitioner was discharged due to disability prior to the receipt of her official separation orders.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's official separation orders (BUPERS order: 1643) were issued on 16 May 2023 vice 13 June 2023.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.
