1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that her naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 1 April 2021 for 4 years and was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).

2. The Board, consisting of ██████████, ██████████, and ██████████ reviewed Petitioner's allegations of error and injustice on 26 October 2023 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 30 March 2015, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 29 March 2019 and Soft EAOS (SEAOS) of 29 March 2021; "Training in the Nuclear Field. MILPERSMAN 1510-030 and MILPERSMAN 1306-500, 1306-502, and 1306-504 (NF) are governing directives. Advancement to Rate and Grade per MILPERSMAN 1430-010. I understand that this extension of active service becomes binding upon execution, and thereafter may not be cancelled. Except as set forth in MILPERSMAN 1160-040 and 1510-030. In particular, I understand that when I accept advancement to E4, 12

months of this agreement may not be cancelled whether or not I complete Nuclear Power or Advanced Training.”

b. On 8 November 2016, Petitioner was issued official change duty orders (BUPERS order: 3136) while stationed in [REDACTED] with an effective date of departure of December 2016. Petitioner’s ultimate activity was [REDACTED] for duty with an effective date of arrival of 26 January 2017 with a PRD of January 2021.

c. On 22 December 2016, Petitioner was issued official modification to change duty orders (BUPERS order: 3136) while stationed in [REDACTED] with an effective date of departure of January 2017. Petitioner’s ultimate activity was [REDACTED] for duty with an effective date of arrival of 28 February 2017 with a PRD of February 2021.

d. On 20 January 2017, Petitioner transferred from [REDACTED] and arrived to [REDACTED] on 28 February 2017 for duty.

e. On 8 September 2017, Petitioner reenlisted for 6 years with an EAOS of 7 September 2023 and received a Zone A SRB.

f. In November 2019, Petitioner was awarded NEC N77Z. In January 2020, Petitioner was awarded NEC N25S.

g. In accordance with reference (b) (15 April 2020), this NAVADMIN announced revised SRB policy for Active Duty and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

h. In accordance with reference (c) (30 April 2020), FY20 SRB Award Plan (N13SRB 003/FY20) a Zone “B” SRB with an award level of 5.5 (\$100,000 award ceiling) for the MMN(SW)/N250/S rate/NEC was listed.

i. On 18 June 2020, Petitioner was issued official change duty orders (BUPERS order: 1700) with required obligated service to December 2023, while stationed in [REDACTED] with an effective date of departure of November 2020. Petitioner’s ultimate activity was [REDACTED] for duty with an effective date of arrival of 16 December 2020 with a PRD of December 2023. Obligated service to December 2023 is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106. para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.

j. On 1 July 2020, Navy Standard Integrated Personnel System (NSIPS)/Electronic Service Record (ESR) shows a 3-month agreement to extend enlistment with an SEAOS of 7 December 2023.

k. On 18 July 2020, Petitioner was issued official modification to change duty orders (BUPERS order: 1700) while stationed in [REDACTED] with an effective date of departure of November 2020. Petitioner's ultimate activity was [REDACTED] for duty with an effective date of arrival of 16 December 2020 with a PRD of December 2023.

l. On 6 November 2020, Petitioner transferred from [REDACTED] and arrived to [REDACTED] on 28 December 2020 for duty.

m. In accordance with reference (d) (19 February 2021), FY21 SRB Award Plan (N13SRB 003/FY21) a Zone "B" SRB with an award level of 7.5 (\$100,000 award ceiling) for the MMN(SW)/N250/S rate/NEC was listed.

n. On 30 March 2021, Petitioner entered Zone B.

o. In April 2021, Petitioner was awarded NEC 805A.

p. On 30 April 2021, Petitioner transferred from [REDACTED] and arrived to [REDACTED] on 30 April 2021 for duty.

q. On 31 January 2022, Petitioner transferred from [REDACTED] and arrived to [REDACTED] on 31 January 2022 for duty.

r. In January 2023, Petitioner was awarded NEC N89X.

s. On 14 February 2023, NSIPS/ESR shows a 6-month agreement to extend enlistment with an SEAOS of 7 June 2024.

t. In the advisory opinion, attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 18 June 2020, Petitioner was issued BUPERS order: 1700 with required obligated service to December 2023. At that time, a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. Petitioner entered Zone B on 30 March 2021. On 1 July 2020, NSIPS/ESR shows a 3-month agreement to extend enlistment to meet the OBLISERV. The Board determined that Petitioner should have signed a NAVPERS 1070/613 agreeing to extend enlistment for 3 months to meet the OBLISERV vice extension of enlistment. On 1 April 2021, Petitioner would have been eligible to reenlist for 4 years and receive a Zone B SRB.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 3-month agreement to extend enlistment (NAVPERS 1070/621) operative on 8 September 2023 is null and void.

Petitioner's 6-month agreement to extend enlistment (NAVPERS 1070/621) operative on 8 December 2023 is null and void.

Petitioner executed an Administrative Remarks (NAVPERS 1070/613) on 1 July 2020 agreeing to extend enlistment for 3 months for OBLISERV to December 2023.

Petitioner was discharged 31 March 2021 and reenlisted on 1 April 2021 for a term of 4 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "7.5" (\$100,000 award ceiling) for the MMN(SW)/N25S rating/NEC. Remaining obligated service to 7 September 2023 will be deducted from SRB computation. Furthermore, that any other entries affected by the Board's recommendation be corrected. Contact Assistant Nuclear Enlisted Program Manager, N133D, [REDACTED] concerning SRB payment.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
